Prayer Points:

We participated in the 40 Days for Life Fall campaign. We had people join us from each our VBC campuses. We had a group prayer service midday and were blessed to hear a testimony from Kim Lescelius.

We've included the follow-up from Philip Price, Aurora Coordinator for 40 Days for Life. He is talking about our group in the second paragraph—PRAISE GOD!

I wanted to share some numbers with you. The final number of babies saved during the 40 Days for Life Fall vigil is 539!! Praise the Lord. God surely answered prayers this Fall in Aurora as we saw 5 women choose life for their baby, 1 person who was seeking forgiveness and numerous conversations with people that were passing by. A Special "THANKS" to those who were able to come out and pray.

During the 40 Days for Life Fall vigil, we were able to experience the **power** of presence, just being present on the Hill across from Planned Parenthood praying. I was asked to speak at a church vigil across the street from Planned Parenthood on the power of presence. The Sidewalk Counselor came and told me as the vigil was starting, "Please be in prayer for a Hispanic couple who was on their way into Planned Parenthood but is now at Waterleaf". One of the vigil participants observed a conversation the Sidewalk Counselor had with a man seeking Mercy because of being involved with two abortions as people were arriving. The Sidewalk counselor and I switched so he could tell the story and I could reach out to women that were pulling into Planned Parenthood's parking lot. During this time, I was able to reach out to a

woman and take her up to Waterleaf. That afternoon, we saw the power of presence! Throughout the 40 Days for Life vigil, we experienced God answer our prayers through our presence.

We also attended the Public 4Life vigil outside Planned Parenthood. Education

During the month of January our Life Matters Team spent each Sunday teaching four sessions on pro-life topics. The sessions included information on defining life, why human life is sacred, defining abortion, the history of abortion legislation, current legislation, history of Planned Parenthood, and how to defend pro-life beliefs. We also learned about our local pro-life pregnancy resource center and abortion recovery services from Caring Network.

Re: SB 1909 - Creates the Deceptive Practices of Limited Services Pregnancy Centers Act

ILLINOIS ATTORNEY GENERAL KWAME RAOUL AGREED FOR SB 1909 TO BE "PERMANENTLY ENJOINED" FROM ENFORCEMENT OF THE LAW.

Most of last year, Illinois Attorney General Kwame Raoul, and an assistant A.G repeatedly said that SB 1909 was constitutional and needed to protect against certain "deceptive" speech. After SB 1909 was signed into law by Gov. J.B. Pritzker, it was immediately challenged in federal court by pro-life attorneys. Federal Judge Lain Johnston this past August temporarily blocked the law from being enforced in saying it was "both stupid and very likely unconstitutional." "It is stupid because its own supporter (assistant A.G.) admitted it was unneeded and was unsupported by evidence when challenged. It is likely unconstitutional because it is a blatant example of taking the side of whose speech is sanctionable and whose speech is immunized – on the very same subject no less," Johnson wrote.

During last year's Spring Session, our organization, along with others, told legislators that SB1909 was clearly unconstitutional because it was forcing a particular speech on pro-life pregnancy centers because they did not encourage abortion and that SB 1909 was taking a side on speech concerning the issue of abortion. We said our pro-life attorneys would quickly challenge it. We were ignored!

This past December, Attorney General Kwame Raoul finally agreed for SB 1909 to be "permanently enjoined" which certainly suggests he now admits it was unconstitutional all along!

ANTI-LIFE LEGISLATION

SB 3499 - 'END OF LIFE OPTIONS' ACT

PROPOSED BY SEN. LINDA HOLMES

Legalizes assisted suicide in Illinois. It is poorly named the "End-of-Life Options for Terminally Ill Patients Act." This bill has numerous problems for the patients, including non-terminal patients, and unconstitutional requirements for religious hospitals and pro-life doctors. A legal analysis is available from Illinois Right to Life Action.

HB 4867 - AMENDS THE ILLINOIS HUMAN RIGHTS ACT

PROPOSED BY REP. ANNA MOELLER & REP. KELLY CASSIDY

Amends the Illinois Human Rights Act to make it a violation if an employer (and other entities) "discriminates" against a person making a Reproductive Health decision affecting the use or intended use of health care, goods, or services related to reproductive processes, functions, and systems, including... family planning, pregnancy testing, and contraception; fertility or sterilization care;... continuation or termination of pregnancy (abortion). This inhibits a Pregnancy Resource Center's ability to hire a person who shares in the mission of the pro-life organization (Right of Association).

HB 5239 - AMENDS THE REPRODUCTIVE HEALTH ACT

PROPOSED BY REP. KELLY CASSIDY

Prohibits the State from providing any information or expending any time in furtherance of any interstate investigation seeking to impose civil or criminal liability upon a person for the provision, or seeking of an inquiry about reproductive health care products or services (abortion). This prohibits Illinois state government from cooperating with other States in their civil or criminal investigations dealing with illegal abortions in their States or human trafficking of minors. This will encourage human traffickers to bring their victims to Illinois for abortions so they can continue to abuse them.

HB 4112/SB 2639 - AMENDS GROUP INSURANCE ACT

PROPOSED BY REP. MARGARET CROKE & SEN. MICHAEL HASTINGS

Expands the requirements that insurance plans pay for In Vitro Fertilization (IVF). This will cause the destruction of more live human embryos.

HB 5142/SB 3665 - AMENDS INSURANCE CODE

PROPOSED BY REP. ROBYN GABEL & SEN. LAKESIA COLLINS

Amends the Illinois Insurance code to provide that insurers cover all services for pregnancy, postpartum, and newborn care rendered by doulas or licensed certified professional midwives, including home births, home visits, and support during labor, abortion, or miscarriage. This would be an excellent bill if it did not include abortion. Anti-life legislators are ensuring that pro-life legislators will not vote for this bill and then criticize them in elections for not supporting midwives and doulas.
