#### **Old Business**

1. 2025 Budget Preparation:

The 2025 Proposed Budget was handed out at the meeting. Several questions were asked. Jan Haigler, Treasurer and David Lucas, Finance Chair provided detailed answers to the questions. After the question and answer session, President Shealy moved to call the question to present the proposed 2024 GSLC Budget to the Congregation. Several seconds were offered. A voice vote was taken and the motion was **Unanimously Approved.** 

2. Upcoming Council Elections:

Council nominees submitted by Council who have agreed to serve if elected: Kate Ferlauto, Sid Havird, Mary Margaret Hoy, David Lucas, Becky Shealy and Deborah Whitlow. Nominations from the floor will be accepted at a Congregational Meeting on Sunday, November 24, 2024, immediately following the worship service.

Note: At the March 11, 2024 Council Meeting, the following motions were approved: Executive Committee moves to amend the number of Council members from 10 to 11 beginning with the year 2025 and from 11 to 12 in the year 2026. The Committee also moves that Council Members would be eligible to receive a second two-year term following the completion of the first term. Council members would be required to be off Council for 1 year following the second consecutive term before being eligible for reelection. The Committee also moves the number of nominees shall be the number required to fill the vacant positions to Council with additional nominees coming from the floor.

3. Upcoming Foundation Board Elections:

The Foundation Board has nominated Ed Woodward to serve. Nominations from the floor will be accepted at a Congregational Meeting on Sunday, November 24, 2024, immediately following the worship service.

- 4. Sale of Good Shepherd Bus:
  - a. On October 20, 2024, Richard Inman, Property Committee Chair Briefed Council that the Property Committee approved the sale of the GSLC Bus. The bus had been used only several times since December of 2023. As a result, David Lucas brought forth a motion that Property Committee move forward on selling the bus. The motion was unanimously approved.
  - b. On October 24, 2004, Mr. Inman sent an email to Council members stating that the appraisal on the bus was and that he had received an offer of submit a vote of Yes or No on whether to accept the offer. All Council members voted "Yes".
  - c. On November 8, 2024, the GSLC Bus was sold to Christian Academy, located in Myrtle Beach for The payment for the bus was deposited in the Money Market Account. After the payment cleared the bank, the Title to the bus was sent to the buyer via Overnight FedEx.
- 5. Status of Non-Standing Business:
  - The Mutual Ministry Committee is awaiting responses from nominees.
- 6. 2025 Committee Assignment Preferences: At the meeting, returning/potentially returning Council Members were given the opportunity to submit their committee assignment preferences for Council Year 2025.
