 present the 2026 GSLC Budget to the Congregation for approval at the December 14, 2025
 Congregational Meeting. A voice vote was taken. The vote to present the submitted budget to the
 Congregation for approval was Unanimous.

 - b) <u>December 14, 2025</u>: Called Congregational Meeting to vote to Approve Budget and also Vote for New Council and Foundation Board Members.
