The U.S. District Court for the Western District of Washington, and then the U.S. Court of Appeals for the Ninth Circuit, sided with the school district. The case eventually landed in the U.S. Supreme Court. In January 2022, the Supreme Court agreed to hear the case. The Supreme Court ruled in favor of Coach Joe.


