 - 1. Ken explained how funding was established in the past. It is difficult to use this same process now (post covid).
 - 2. We have not been spending to budget. It has been a difficult year. Giving is much less than expected. We had money in the bank and were able to cover some of this discrepancy but it was more than expected.
 - 3. Explanation of how we built our plan for this year. We want to match up to expected giving this year. We still have cash in the bank but hope to not have to tap into this.

 - 1. We need to make changes at this point and some are significant changes.
 - 2. Background In the past 5 years, we have had some very generous cash gifts come in, in addition to regular giving. We also had the PPP (Payment Protection Program) loan, which we did not have to pay back. We have not had these big gifts come in and we felt we needed to do more to cut expenses.
 - 3. Cathy presented the Ministry Funding Plan (located in the Annual Report). We are relying on over \$21,000 less per week in spending average weekly giving currently

is just over \$64,000 per week. Cathy pointed out our savings in staffing cost (mostly due to staff reductions). Also, our wearbook reserves – we are foregoing any addition to this account this year but would like to add it back in next year. Looks like IT has increased but actually this increase reflects hiring an IT contractor which is offset by a greater savings in salary payments formerly paid to an IT employee. We are not giving up ministry, but trying to reimagine how we do things. Each department does have scholarship money available if needed.

- 4. What if our giving still doesn't meet our spending needs? We will continue to monitor this weekly. We will keep the congregation informed. We can sell assets or consider another staff reduction. This is not in our plan.
- 5. How can we help achieve giving to budget? Evaluate your personal giving. Give all summer long. If you have RMD's from your IRA, call Cathy re: QCD's. Volunteer! Pick up the check if meeting with a pastor or staff member at a restaurant.
