# APPLICATION AND EXHIBITOR GUIDELINES FOR THE ANNUAL CHRISTMAS BOUTIQUE AND BAKE SALE December 6, 2025

It is the intention of the Guardian Angels Women's Club of Guardian Angels Catholic Church, Oakdale, MN to limit the Annual Christmas Boutique to exhibitors who make their own **ORIGINAL**, **HANDCRAFTED ITEMS**, **NO COMMERCIAL ITEMS ALLOWED**.

A space is not considered reserved until an application and payment is received by the Committee. **EARLY REGISTRATION IS IMPORTANT!** The Committee reserves the right to make the final judgment on which exhibitors will be allowed to display their items. We reserve the right to limit the number of vendors selling similar products (examples jewelry, mittens, jams/jellies). This provides better opportunities for the sellers of those products as well as encouraging product variety. Please be specific as to the items you wish to display on the application. Providing a picture(s) is encouraged. You will be contacted as to whether or not you will be accepted. **A CONFIRMATION WILL BE SENT TO YOU VIA MAIL OR EMAIL.** If you have questions regarding your confirmation, please give us a call at 651-738-2223.

#### **EXHIBITORS GUIDELINES**

#### **EVENT INFORMATION**

- 1. The Boutique is sponsored by the Guardian Angels Women's Club. Proceeds from this event support our work within our parish and local community.
- The Boutique is limited to exhibitors who make their own ORIGINAL, HANDCRAFTED ITEMS. Any
  exhibitor displaying unapproved items will be asked to remove those items during the sale. Please
  note: Exhibitors with scented items (i.e. soaps, perfumes, oils, etc.) must keep items wrapped or
  capped for comfort & safety of all.
- 3. **ONLY GUARDIAN ANGELS WOMEN'S CLUB CAN SELL BAKED GOODS & CANDIES**. Store-bought, individually wrapped candies may be used within items to help showcase the use or purpose of handcrafted items but may not be sold individually or separately.
- 4. The sale takes place Saturday, December 6, 2025, from 9 am to 4:00 pm. **EXHIBITORS ARE EXPECTED TO BE THERE THE ENTIRE TIME**. If you must leave unexpectedly, contact a Women's Club member. Someone is always at the Raffle table.
- 5. Parking: ALL EXHIBITORS ARE ASKED TO PARK IN THE LOWER CHURCH PARKING LOT AFTER SET UP.
- 6. **LUNCH will be available for purchase and delivery.** Donuts and rolls will be available for purchase in the morning. Free coffee (8 oz. cup) is available for exhibitors from 7 am to 9 am.
- 7. **Exhibitors processing credit cards need to provide their own secure network (hot spot**). Guardian Angels only provides an open unsecured network for other activities such as searches, etc.

- 1. **EXHIBITOR SPACES MEASURE 8 FEET WIDE BY 6 FEET DEEP AND ARE AVAILABLE FOR \$50**. An exhibitor may rent either one space or two (limit of two per vendor). Space requirements will be strictly enforced for traffic flow safety **NO CHAIRS OR DISPLAY ITEMS CAN BE SET BEYOND THE TAPED LINES** of your space. Please keep this in mind when planning displays and during set-up.
- 2. You may provide your own table. However, six-foot rectangular tables are available for rent for \$20 each. IF A TABLE IS NOT RESERVED, WE CANNOT GUARANTEE TABLE AVAILABILITY ON EVENT DAY.
- 3. Although we cannot guarantee the availability of electricity, you should indicate your need for electricity on the application, and we will try to locate your space near an outlet. **PLEASE BRING YOUR OWN EXTENSION CORDS AND DUCT TAPE** for securing electrical cords to the floor.
- 4. If you have a special need or location preference, please assist us by sending in your application early! We will do our best to accommodate your request.
- 5. We will **send you a confirmation** by mail or email after your application has been approved. If you have questions regarding your confirmation or have not received a confirmation (after sending in your application), please give us a call at 651-738-2223.
- 6. In addition to the application, the **Archdiocese requires all Exhibitors to sign an Indemnity Agreement.** Please include this signed agreement with mailed application. If you register online, the agreement will be part of the application. An electronic typed signature is acceptable.
- 7. **CANCELLATIONS**: A full refund will be made only if a replacement exhibitor can be found.

#### **SET-UP INFORMATION**

- Follow directions to Social Hall parking. SET UP IS SATURDAY, DECEMBER 6, 2025, BETWEEN
   7 AM AND 9 AM. Early set-up on Friday will not be permitted. ENTER THE CHURCH FROM THE LOWER (SOUTH) PARKING LOT. Carts are available for you to use.
- 2. DISPLAYS MUST BE REMOVED BY 6 PM.
- 3. For reasons of safety and consideration, DISPLAYS MAY NOT EXTEND BEYOND THE 8' BY 6' EXHIBITOR SPACE for traffic flow safety. There may or may not be a wall behind your space. You may bring a backdrop to display your items, but it must be able to stand on its own.
- 4. Guardian Angels will not supply tablecloths for display tables.
- 5. Be sure to fill out an evaluation before leaving the boutique. We welcome your comments.
- 6. PLEASE KEEP THIS INFORMATION FOR REFERENCE DURING THIS YEAR'S BOUTIQUE.
