Groups – Carl Albing

- Training session for Group Leaders on 9/7 will emphasize "Who's Next?" identifying new leaders for ministry and groups.
- A survey will be distributed this fall to see how groups ministry is being received and identify areas of opportunity.

Adults/Welcome – Craig Pearson

- iPad Kiosks are installed in the Welcome area this will streamline communications and engagement.
- 4 new members joined the Welcome team, and 2 others joined the Hospitality team.

Treasurer's Report – Dennis Engman

- Reviewed July General Operating fund actuals and balances, including Missions funding.

- Mike Mathisen asked the council to adopt a corporate resolution dated 8/13/24 to update the resolution previously adopted in 2022 to allow the Executive Director to make updates to bank accounts.

 - Motion moved, seconded and passed unanimously.
- Mike Mathisen requested an allocation from reserves up to \$6000 to hire Pope Design Group to review the Community of Grace campus structures to determine suitability for any possible future plans stemming from the Kairos project.
 - Motion made by Dennis Engman, seconded by Carl Albing. Discussion ensued.
 - Motion passed unanimously.

Vice President – Andy Hennig

- Audit Committee (Andy Hennig, Mike Mathisen, Keith Nelson, Sue Quinn, Rex Kiekhofer, Steve Nelson, Jeff Montgomery) met June 23rd, and reviewed the final report from an external audit by Brian Ulrich of CCS which concluded in April of 2024.
 - For the first external audit in decades, the recommendations were very minor.
 - At the time of the Committee meeting, all recommendations had been acted upon and resolved to the satisfaction of the auditor except 2 open items:
 - Develop a Records Retention Policy

- The team has asked for examples to create a policy and present to council.
- This will be the subject of a future council meeting.
- Develop an Unreconciled Aged Items Policy
 - These are checks written by CGLC but not cashed by recipients.
 - Steve Nelson agreed to research MN Statutes on this matter and propose a path to the team. This was determined not to apply to our process.
 - The team has now created and implemented a policy to reconcile items aged more than 12 months old each month.
- The auditor recommended a once every 3 years audit cycle for the future.
- Planning for Rally Sunday Breakfast signup will be sent this week
