Rector's Report

The pages of this annual report bear witness to a very special Christian community. The ministry of our church is made possible by God, along with the faithful commitment of our staff, lay leadership, and many members of our church. Alongside the ongoing ministries, we also experienced growth and changes in 2024. It was a time of challenge as well. It was a difficult and tender year for me, given the tragedies and deaths in my family. I will never forget the ways in which Meaghan, Karen, lay leaders, and members walked with me through it. I am grateful for the ways you supported me, picked up what I dropped, and allowed me to lead as I was able. Thank you for encouraging the sabbatical leave I took in the fall. It made all the difference for me to have this healing time. I have returned, strengthened in faith and gratitude for the ministry we share. It was a singular experience to be the rector of our growing, vibrant, changing church in 2024. Here are some of the noteworthy highlights and new developments.

- It was a time of growth in numbers. **Thirty-three (33!) new members** joined our church, many of whom are already participating in ministry.
- Meaghan and I began to settle into our ministry partnership, defining rolls and rhythms.
- Karen Laroche, Parish Administrator grew in her position as we changed our church yard ministry. Along
 with Property Manager, Jon Walker, Karen coordinates much more of the burial process and oversight as well as
 other increased administration.
- Beginning in 2025, Karen Laroche is **full-time with a new title**, Pastoral Associate for Administration. This recognizes the increase in responsibilities as well as the pastoral dimension of her important ministry. Meaghan, Karen, and I are grateful to share pastoral ministry with one another and to support our members in theirs.
- In June Michael DiMucci began his ministry as Pastoral Musician. The choir and our music program have grown and added depth and joy to our Sunday morning and special worship services.
- In September, we began a major renovation of the rectory, one that included removing a wall, widening doorways between downstairs rooms, changing some windows and doors, and updating some painting and lighting. This work will make the home much better for entertaining the parish as well as improving the layout and functionality for rectors and their families.
- The Christian formation team formed, and **began a thriving new ministry**, **Family Dinners**. These monthly meals are an intergenerational opportunity for fellowship, meaningful Christian formation, and worship. Well done, Meaghan and team!
- We had our **first Great Vigil of Easter since 2019** and it was an extravagant celebration. Many participated in the story telling, music, and hospitality that followed.
- The Vestry reinstituted a finance committee to offer greater oversight and review of our financial resources.

While we are poised for continued growth, our staff, lay leaders and I are committed to tending and deepening the community life God has already planted here. I invite all members of St. Mary's to discern your role, both in giving and receiving as we share ministry. It is my privilege and joy to serve as your Rector and I look forward to what God will grow in our future.

From the Bylaws of St. Mary's Church, Portsmouth

Article IV, Section 1. Membership. The Members of the Parish shall be all persons who have received the Sacrament of Holy Baptism and are registered as members of the Parish. Minutes of the 2024 Annual Meeting of the Corporation of St. Mary's Sunday, February 4, 2024

The rector, the Rev. Jennifer Pedrick, called the 2024 Annual Meeting of St. Mary's Corporation to order at 10:25 a.m. She thanked everyone who made this meeting possible, especially Murry Edwards, for once again putting together a wonderful annual report, and all those who submitted information and reports.

The rector then offered a prayer.

Mattie Gustafson, parish clerk, confirmed that a quorum was present. (21 members are required for a quorum.)

Jennifer pointed out an error in the published agenda – the corporation does not need to accept the special minutes of March 13, 2022. This item was removed from the agenda.

- A motion was made and seconded to accept the minutes from the 2023 Annual Meeting, held on Sunday, February 5, 2023. The motion was passed.
- A motion was made and seconded to accept the 2023 Annual Report and its contents, excluding the report from the Nominating Committee, the Financial Report, and the Proposed 2024 Annual Budget. The motion passed.

Acknowledgment and Gratitude for Retiring Vestry and Other Leaders - Jennifer

Lee Ferreira - has served St. Mary's for three years on the vestry, beginning this role during the pandemic. She has been instrumental in leading the Invite Welcome Connect ministry. She has helped us to lead through the pandemic and rebuild our ministry with children and families. She coordinated the program last spring called Creation Care Kids as well as St. Nicholas Sundays. Lee has been a steady and gracious leader in offering hospitality to our members and friends. It

has been a gift to have Lee as a member of the vestry and to experience her growing faith and deep commitment to this church. We thank you for your ministry, Lee.

Rick Updegrove — Completing a three year term. While on the vestry he has offered leadership and wisdom. With his background in the law, he has been a huge help in creating leases, in guiding me as the rector on all kinds of things. Rick has also served as a lector and a delegate to Diocesanre Convention. Rick has been a great and gracious leader at St. Mary's. I am looking forward to working closely with him in his tenure as senior Warden.

My first year as senior warden has certainly been memorable. Winter witnessed tragic losses for the St Mary's community. The compassionate response of the entire congregation set the tone for the entire year.

Our 2024 vestry immediately coalesced under the stress of tragedy; the support and solidarity of the entire vestry has been a hallmark of the 2024 year. During this period of loss, the vestry continued to responsibly address other issues facing the church. The vestry began planning to complete its capital maintenance responsibilities by addressing deferred repairs and improvements to the rectory building. Fresh with the experience of renovating the historic church, the vestry determined the scope of the rectory rehabilitation, engaged engineers to perform a due diligence evaluation of the project, accepted and reviewed bids for the project, and engaged a contractor. Work began at the end of September and continues to progress at the present time. Kudos to junior warden, John Corbishley, for his diligent work as clerk of the works for this project. And a big thank-you to those members of the church who attended the parish meeting at the end of September; your support and suggestions have been instrumental to the success of this construction. Also, a huge thank-you to the donors who generously funded this project, making the need for financial contributions from our operating budget virtually non-existent.

In addition, Jason Defalco has successfully led the Christian formation effort. St. Mary's congregation continues to grow as a direct result of Jason's efforts. This program was coupled with an ambitious and effective summer schedule of activities, including concerts, beach picnics, and other activities. Thanks to the Rev. Meaghan Brower for her support of the beach picnics, which were very successful community-building efforts. The church's family dinner program launched this fall has been well attended and has helped offer a means for younger families to experience the St. Mary's spirit.

Finally, the vestry has successfully weathered the sabbatical of our rector. The Rev. Meaghan Brower's leadership has been incredible during this period. We welcome the Rev. Jennifer Pedrick back and look forward to her leadership in the coming year.

Work of the Vestry 2024

February 29, 2024

Voted to reopen the search for a church musician.

Accepted the Parochial Report, which was then submitted to the Diocese.

April 25, 2024

Authorized repair work on several stained-glass windows in the historic church, as described in the Burman quote.

July 25, 2024

Gave preliminary approval to spending \$275,000 for the rectory renovation, and approved spending some of the money already on hand to cover the cost of deposits that are required to enable the project to move forward. This motion passed unanimously.

Approved allocating \$75,000 from existing surplus and gifts already received to cover the costs of initial deposits for this project. This motion passed unanimously.

Approved a 3-month sabbatical for the rector, Jennifer Pedrick.

August 22, 2024

Changed Karen LaRoche's job title from Parish Administrator to Pastoral Associate for Administration, and increased her hours to full time.

Approved the withdrawal of money from the vestry restricted fund named "Perry – altar window" for the purpose of paying for the repairs to the stained-glass windows in the church.

Accepted the proposal by GW Renovations for the renovation to the rectory. Designated John Corbishley as the contact person for the contract and authorized him to sign a contract consistent with GW's bid. This motion passed unanimously.

September 26, 2024

Junior Warden's Report on the Property

St. Mary's property and the buildings that serve its community require constant attention whether maintaining, repairing, keeping them up-to-date, or modifying them to better meet the needs of the parish. 2024 was a busy year in attending to these goals.

Jon Walker, our property manager, takes the lead for maintaining our 80 acres of property and buildings. General improvements beyond routine maintenance included

- completing **new fencing** around the community garden,
- removing diseased trees, as well as two large trees that blew down along the Bridal Path,
- and pruning trees around the rectory for safety reasons.

This year the Karen LaRoche and Jon Walker assisted in changing how we manage the cemetery. Prior to 2024, an outside contractor conducted all aspects of burial. Because our relationship with the contractor changed, we looked at best practices for caring for the deceased and their families.

- We reviewed state regulations to insure that we are in compliance regarding escrow of funds for perpetual care.
- We evaluated the processes for interments since services need to happen quickly in the event of a death.
- As a result, we moved the coordination of burial in-house. Karen Laroche, Pastoral Associate for Administration, coordinated church responsibilities with the bereaved, and Jon Walker handled the outdoor elements of interment.

Even though the historic church renovation ended in 2022, like any historic building it is in constant need of attention. In the spring, a leak was discovered at the base of the Ascension window. After examining the framing around the Ascension window and the other windows in the church, we did several things to preserve the windows.

- Areas of stone that had eroded over the past 100 years were built out to better support and seal the framing of the windows.
- We also replaced the plexiglass protective sheet covering the windows with vented lexicon, a stronger material that will prevent the heat buildup that can weaken the lead panes holding the glass.
- Fortunately, our insurance company covered some of the costs as did the generosity of a past parishioner who had set up the Perry - altar window fund. As a result, we were able to complete the \$51,000 project without going into our operating funds.

Also in 2024, a parishioner's generosity allowed us to begin the first major rectory renovation project in 30 years. As the project's estimated cost of \$275,000 became apparent, other parishioners stepped forward with donations to make sure it could be expanded and to include the updating of other areas of the first floor in addition to the kitchen. The scope of the project was to

- renovate the kitchen, open the dining room area and expand the opening from the dining room into the living room;
- enlarge the passage from the dining area to the back porch;
- put in new cabinetry, appliances, and lighting.

Because of this renovation, the first floor of the rectory will have a more **open**, **updated floorplan**. This should do us well for at least the next 30 years .

Many of you have seen the activity in the Gibbs House this past year. In January, 2024 we rented the space to Looking Upwards, a local nonprofit, that is operating an arts and crafts program for developmentally challenged individuals.

All this work is a direct result of the generosity of the members of our church community and I thank you for providing the resources to maintain this property that has been entrusted to us.

2024 Financial and Investment Reports

In 2024 we experienced some significant changes in our ministry and staffing. With the vestry's careful planning, the community's generosity, and God's provision we had a solid year. As we are growing, we see an impact on our financial life. Some of this growth increases our income, yet growth also increases our expenses. Over the course of 2024 we now have four full-time staff members and a quarter time pastoral musician. We have also added new programs. This was a planned and necessary part of our continued growth and mission. As the treasurer, it can be challenging to guide us in the midst of change!

Income

In several categories, year end income was significantly ahead of budget. Pledges finished \$32,205 over budget. Loose offerings were \$10,000 over. Donations were \$30,000 over. Our building and land use, which includes income from the churchyard, was \$23,702 over budget. We expected a shortfall in this first year with a second full time priest, so we allocated \$72,600 of previously received unexpended funds to the 2024 budget. Thanks to the strong income items above, we did not need to use the entire amount allocated. Most of this money is still available to use for future projects.

Expenses

We had several unforeseen developments that impacted our expenses. We finished the year approximately \$12,000 over budget in expenses. This was the result of unplanned first quarter changes in how we managed the churchyard. There were personnel expense increases as a result. We had not anticipated a sabbatical for the Rector as we created the budget. This added modest personnel expenses as we paid other pastoral personnel to offer ministry in the rector's absence. While some expense items were under budget, the net result in expenses was \$12,000 over budget for the year. When combined with a slight shortfall in income, this results in the net deficit of \$14,655.

Endowment

The financial markets put in another very strong showing during 2024. This was reflected in our endowment performance, which ended the year up approximately 14.04%. Endowment draws were exactly on budget at \$211,176, representing an approximately 6.3% draw for the year.

The Investment Committee met quarterly with the investment manager (Van Liew Capital) to review strategy, holdings and performance. There were no changes to the portfolio allocation, which continues to have an equity target between 60-70%. We continue to hold approximately 1 year of future draws in a conservative bond fund, which ensures that we would not need to liquidate investments during bearish conditions.

Looking Forward — 2025 and Beyond

During the budgeting process the newly reinstituted Finance Commission, in concert with the vestry, discussed the funding challenges facing us in 2025. These include funding the personnel expense of our growing church, as well as the programs that will support our membership. We established a somewhat aggressive goal of \$325,000 for parish pledges. We reluctantly agreed to increase our draw from the endowment to the maximum allowed by the Diocese of 7%. We still have a small amount of previously received unexpended funds available. Increasing the draw is a short term solution as it is our practice to keep our draw lower. In order to support the continued growth of our parish we need to increase the amount that we receive from pledges, offerings and donations. It is my hope that the continued generosity of our parishioners will result in achieving these increases without the higher draw on the endowment. Thank you to all who have been generous with financial support.

Building Community through Worship

Worship is where our community life is most evident at St. Mary's. As we come together to worship and share in holy communion, we are made one with the body of Christ and with each other.

In 2024 our worship life reflected our sense of community in various ways.

- We regularized **beach compline** along with a bring-your-own picnic during the summer with monthly Sunday evening gatherings from June to August at Third Beach in Middletown.
- We worshiped with each other and the larger community through **numerous funerals**, one of which was for former St. Mary's rector, the Rev. Gordon Stenning.
- We celebrated jazz eucharists with the Lois Vaughn Quintet in July and December and welcomed many guests to worship.
- We welcomed **Michael DiMucci as our new pastoral musician**. Under his leadership, the choir gained new members and continued to support each other in their ministry.
- The altar guild, lectors, and greeters supported the clergy in over 100 weekend worship services, 3 Holy Week services including a return of the Great Vigil of Easter, 3 Christmas services, and 5 funerals. The dedication of these lay ministers to our St. Mary's community was outstanding.
- The audio-visual team broadcasted 10:00 worship services and special services on Facebook and YouTube
 which allowed an average of 14 viewers per service to watch on line, bringing those who couldn't be
 physically present into the worshiping community.

Creating Community through Well-Being

Throughout 2024, St. Mary's created community within and without the parish by looking after the well-being of our members and offering events to foster well-being for others.

The newly formed Hospitality Team coordinated events including coffee hour, Bites and Beverages, collations, monthly Family Dinners, and special events. 2024 highlights of this team include

- providing fellowship following worship by scheduling monthly coffee hours after the Sunday service;
- changing the name of the monthly Wine and Cheese event to Bites and Beverages to show the inclusive nature of the get-together;
- providing collations which offered hospitality for 3 large funerals including that of the Rev. Gordon Stenning, former St. Mary's rector;
- offering dinner before a funeral for a family and providing lunch following a funeral for another; and
- creating a group called Heavenly Hosts who help support social events.

Another **new addition** to help with our well-being was the Christian Formation Team. The team had various new initiatives in 2024 including

- a monthly Christian formation email which highlighted the month's theme, a read-aloud video of a children's book on that theme, and a video of "Ask a Priest";
- **Family Dinners** on the 3rd Wednesday of each month allowed everyone an opportunity to join in fellowship first by eating together and then by giving time for children and adults to separately reflect on the monthly theme;

- **small group opportunities on Wednesdays** that included a weekly Lenten group to reflect on the theme of forgiveness and the Faith Friends Book Group that met to discuss RIchard Rohr's *he Universal Christ*;
- a series of Sunday morning workshops led by Brian Litzenberger, lay associate, on Walk in Love, our stewardship theme for 2024;
- a Rest and Return Retreat on an August Sunday afternoon led by the Rev. Jennifer Pedrick and Jenny Williams:
- a **weekly podcast of the sermon** for those who were unable to attend church. A weekly average of 13 people experienced St. Mary's through this.

Fruits of the Spirit, Fruits of the Summer was the highlight of St. Mary's efforts to celebrate our community while extending a welcome to members and neighbors. Special events included

- **Sundays that featured seasonal fruits** which many parishioners contributed their time whether picking fruit, preparing food, and serving or cleaning up;
- **indoor and outdoor concerts** where we offered hospitality to those who came to hear Caroline Cotter, the Good Living Band, and Bar Fly;
- monthly Sunday beach dinners where members and friends gathered for dinner, a bonfire, and Compline; and
- publishing a cookbook of favorite seasonal recipes.

Other seasonal highlights that added to our community's well-being included a Shrove Tuesday pancake supper and Advent wreath making on the first Sunday of Advent.



The Pastoral Care Team continued to be a pillar of the St. Mary's community and integral in helping create community for those who are able to actively participate in church life as well as those who are home-bound. The team connected St. Mary's members by

- **offering Eucharist to those at home on a monthly basis** with a team of 4 Lay Eucharistic Visitors making over 50 home visits this year to 9 members;
- making 2 dozen pastoral care visits to our homebound members; and
- by sending over 150 cards to members of the church community.

The Community Garden literally grew this year! A grant from the People's Garden project allowed for

- · soil improvement, a pollinator garden, and tools for maintenance; and
- **new plots** which brought new faces to the garden including Looking Upwards and their creative arts affiliate Sunlight Studios.

The Community Garden also contributed to the well-being of our members with flowers for pastoral care visits. The gardeners **hosted a summer gathering after a Saturday service in August to celebrate the garden** with food, refreshments, a garden tour, and live music.

The Prayer Shawl Ministry met on Wednesdays and offered an **opportunity to knit and visit for members of the parish**. While doing this, they completed 32 adult prayer shawls, 3 children's prayer shawls, 5 lap robes, 70 prayer patches, and 2 baptism blankets. Their handiwork went out to members of the parish as well as outside organizations.

Again, the Tuck Fund Committee helped St. Mary's college students by awarding \$33,000 in scholarships to 11 students in 2024. Students who benefited from this scholarship include Bella DeAngelo, Ellen Stack, Emma Adkins, Hailey Pratt, Jae DeFalco, Jane Kaull, Mary Stack, Melanie Williams, Mia Bartlett, Rayna Lombardo, and William Burke.

Creating Community through Service

Throughout 2024 St. Mary's offered opportunities for service to those in Newport County, Providence, and beyond. While these events created connections with others, St. Mary's members also benefited from the community that it helped us form among ourselves.

The Community Outreach Team offered new initiatives and opportunities for service in 2024, which included

- Focusing on the needs of the food and housing insecure in our greater community.
- Offering a coffee hour and book group discussion on **Rough Sleepers** by Tracy Kidder. Over 50 people gathered for this discussion, and everyone was moved by the true story of a special program designed to meet the medical, social and other needs of a group of unhoused that largely live outdoors in Boston.
- Collecting items for "Blessing Bags" that included toiletries, socks, and snacks to be distributed to the unhoused at a later date. In addition, two dentists in the community donated toothpaste and toothbrushes to be included in the bags.
- Using the Annual Day of Service to **help at the Church Beyond Walls** in Providence on June 29. Three teams contributed to making this day a success and creating community while working together.
 - One team worked in St. Mary's kitchen preparing sandwiches and salads and packaging the fruit and desserts lovingly donated by our parishioners.
 - Another team of high school and college students put final touches on the Blessing Bags that were to be distributed at the Church Beyond Walls worship service and meal.

- Finally, a third team participated in the Church Beyond the Walls worship service at Burnside Park and served the prepared meal to approximately 100 food insecure adults that afternoon, who exclaimed that everything was delicious.
- **Providing a coffee hour and book group discussion** about Javier Zamoro's memoir *Solito*, which relates his experience as a young boy from El Salvador who migrated to the United States to reunite with his parents.
- Inviting a guest speaker from Conexion Latina in Newport to provide information regarding the work they are doing with immigrants on Aquidneck Island.

And along with the new initiatives, St. Mary's continued to support the community and create community by

- Hosting the monthly Soup Kitchen ministry at St. Paul's United Methodist Church in Newport. On average, about 70 people attended the Soup Kitchen each month and enjoyed a hot meatloaf dinner.
- Providing a Soup Kitchen dinner at Family Dinner to bring awareness of this ministry to the parish using the monthly theme, "Love thy neighbor."
- Contributing over 1200 pounds of food to the Dr. Martin Luther King, Jr. Community Center which included 4
 dozen birthday cake kits for children.
- Growing fresh vegetables in the Community Garden for the MLKCC Food Pantry.
- Generously giving over \$2500 in gift cards and over 2 dozen toys to the MLKCC Santa's Workshop as well as 19 pairs of mittens, 2 dozen scarves, 1 pair of boots, 58 hats, 10 hat/scarf sets, 2 head bands, and 4 baby blankets.
- Knitting 12 hat/scarf sets, over 100 hats, and 6 red, white, and blue lap robes that went to the Seaman's Church Institute, Conexion Latina, and Pell School Family Center.

Stewardship

The Stewardship Commission is responsible for recording the generous gifts from all who support St. Mary's. All donations, and especially member pledges, provide for the day-to-day operations, which include care for our buildings and property, support for our outreach programs and ministries, and the salaries of our staff. The Commission is also responsible for running the annual pledge campaign and the Historic Church Renovation Campaign which began in 2021 and ended on December 31, 2024

At the heart of stewardship is a call to strengthen our relationship with God through giving and thoughtful prayer about the question: What has God given me, and what can I give in gratitude? This year three members provided testimonials about their relationship with St. Mary's and their intentional process as they make their pledge. This year our theme was **Walk in Love**, a phrase we hear at every service from Ephesians 5:1-2.

Annual Pledge Campaign

In December of 2023 we budgeted \$300,000 in pledges for 2024. The amount of pledge income received in 2024 was \$332,205.

In December of 2024, we have received \$310,000 in pledges for 2025. 116 households participated, a 3% increase from last year. The average pledge for our 2025 budget is \$2,672.


Historic Church Pledge Campaign 2021-2024

Sarah Gibbs Trust

Established by the Sarah Gibbs Trust in 1843, the trustees ensure that the property that Sarah Gibbs gave "to establish an Episcopal Church" is used to meet her wishes. The trustees can be either independent or vestry trustees. The independent trustees are self-nominating for up to seven 3-year terms. The vestry trustees are elected by the vestry for the duration of their vestry term to serve on the Trust. The Bishop of Rhode Island is an ex-officio member of the trust.

In January 2024 Cousens Farm renewed its lease to farm the hayfield during the year.

Ted Bierman accepted reappointment by the independent trustees for a three-year term as an independent trustee when his current term expires March 1, 2025.
