

Approved Council Minutes April 14, 2025

On April 14, 2025, at 6:00 pm Calvary's Strategic Planning Team met with facilitators Dan and Lisa Malmstrom from North Point Consultants to begin the next phase of planning strategically for the future of Calvary. Katie R. began the meeting by reminding us that the Lilly sabbatical grant that Calvary received allowed for the hiring of North Point Professionals to follow up and help develop strategies for the sustainability of Calvary's mission. Introductions were made by all present.

Pastor Hans shared devotion and prayer.

Dan Malmstrom shared an overview of Calvary's Strategic Planning for 2025. Together we will be addressing attendance, generosity, and engagement. Dan also shared the framework of shared vision, strategy, and skills for North Point's planning.

Pastor Hans shared a review of the 2021 planning process with the Malstroms. At that time the planning committee affirmed the work of Calvary with focus on worship, connect, and serve. Calvary's vision and values were created. Six priorities were identified in 2021:

- 1) Fresh and focused kid and student ministry leadership and vision
- 2) Expanding our mission through the Calvary Partner Network
- 3) Online church as our new front door and a home for many
- 4) Grow connect groups to grow our ability to care
- 5) We will be known as our "Community's Church"
- 6) Develop and equip leaders

The next strategic planning meeting will be on May 19, 2025 at 6:00 p.m. The team will begin the work of processing and strategically addressing church engagement, attendance, and generosity.
