Following the publication of this list, we will return to the long-standing practice within the Conference of publishing the mission share status of all local churches twice a year, in July and January. This practice was curtailed during the pandemic, as many churches found themselves navigating new financial realities, and church leaders were simply asked to "do their best." Today, increasing numbers of churches are finding the discipline, grace, and generosity to be more fully connectional.

Local churches have valued this practice in the past. It has historically provided congregations with a transparent view of the Baltimore-Washington connection and their church's place within that connection. We also acknowledge that focusing on improving the mission share collection rate within our connection will provide even more support for reducing the individual mission shares from each congregation.
