"I find that Holy Week is draining; no matter how many times I have lived through his crucifixion, my anxiety about his resurrection is undiminished—I am terrified that, this year, it won't happen; that that year it didn't. Anyone can be sentimental about the nativity; any fool can feel like a Christian at Christmas. But Easter is the main event; if you don't believe in the resurrection, you're not a believer. If you don't believe in Easter," Owen Meany said. "Don't kid yourself—Don't call yourself a Christian."

As I write this it is Holy Saturday and we are on the threshold of the great celebration of our Lord's resurrection from the dead. It is the High Holy Day of the Christian church and the quote above from a popular novel offers an interesting challenge to ponder: Can one deny the truth that is celebrated on this High Holy Day and still be a Christian?

I suppose that one can call them self a Christian and deny the resurrection if their use of the term 'Christian' is so watereddown and redefined to mean nothing more than a cultural association with the Christian church. But is that what it means to be a Christian? To simply be born into a Christian family? To celebrate Christmas instead of Hanukah or Ramadan? Is being a Christian like being an Irish-American or Italian-American, that is, someone who identifies with one culture first, but happily acknowledges certain historical cultural phenomenon especially on holidays? Sadly, for many Christian-Americans, I suppose it is. Rather than holding to a specific worldview and set doctrines and having a

real relationship with the Living God, those who are merely cultural Christians have only a historical connection to true believers. But that is Owen Meany's point: cultural Christians are not real Christians nor should they self-identify as such: "Don't kid yourself-Don't call yourself a Christian."

Scripture defines what it is to be a Christian in terms far different than merely a loose cultural association. The Apostle Paul wrote to the Romans: "... if you confess with your mouth that Jesus is Lord and believe in your heart that God raised him from the dead, you will be saved. For with the heart one believes and is justified, and with the mouth one confesses and is saved." (Romans 10:9-10 ESV) Notice that Paul is specific; saving faith does not merely parrot the words "Jesus is Lord" but true faith trusts in the heart that Jesus was raised from the dead. More texts could be brought to bear on the question of what it means to be a Christian, but for now, let's agree that 'confessing with your mouth that Jesus is Lord and believing in your heart that God

raised Him from the dead' is what it means to be a Christian with saving faith. Let's also agree that there is no meaningful way to call yourself a Christian and at the same time deny that Christ is risen from the dead.

Each week we confess with our lips in the words of the creeds, "I believe ... in one Lord Jesus Christ... who rose again on the third day according to the Scriptures..." We regularly confess this with our lips and by God's grace we trust in our hearts that Christ died and was raised "for us and for our salvation". Yet, the season of Easter is that special time in the Church Year that we set aside to focus on this all important truth that He lives and because He lives, we too will never die. Only real Christians know this and trust in it. How blessed we are to be among those know and believe!

He is risen! He is risen indeed! Alleluia!



#### **Bluebonnets**





## Whose Is It Anyway?

If you have every bought or sold a house, you are acquainted with the concept of a "title search." Before you can sell your house, and before anyone else will feel comfortable putting down the money to buy it, you have to prove that you really own it. So a title company looks through the public records to ensure that you bought it from the person who really owned it, who bought it from the person who really owned it before that, all the way back to the earliest records of your state, including when your state was only a territory or colony of England.

Peak into a preschool classroom during playtime and you'll see a simplified version of this. A child starts playing with a ball, but another child says, "That's mine: I had it first."

You can't understand the Seventh Commandment without understanding this concept of ownership or title. As the Small Catechism puts it:


You shall not steal. What does this mean? We should fear and love God so that we do not take our neighbor's money or possessions, or get them in any dishonest way, but help him to improve and protect his possessions and income.

Your neighbor's possessions are his: you don't have a right to take them. And likewise, your possessions are yours. Ownership and property rights are foundational to any functioning society.

But there is something deeper to know about ownership, and that is the question of who has the title and ownership to you? Paul says, "Or do you not know that your body is a temple of the Holy Spirit within you, whom you have from God? You are not your own, for you were bought with a price" (1 Cor. 6:19–20).

If you yourself are owned by God, then of course everything that you own, you really only possess by God's leave: all of it, at bottom, belongs to Him since you belong to Him. For you were bought with the blood of Christ.

This notion is the foundation of all Christian stewardship. It all belongs to God. It should all be used for things that bring honor to His name, blessings to our neighbors and the extension of His kingdom.
