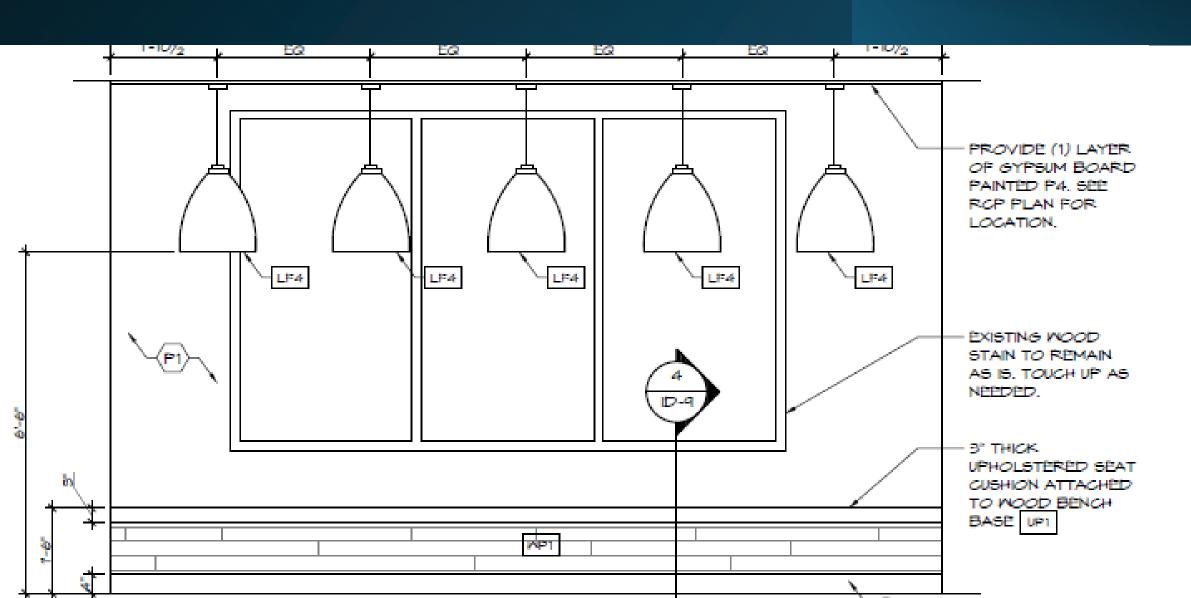

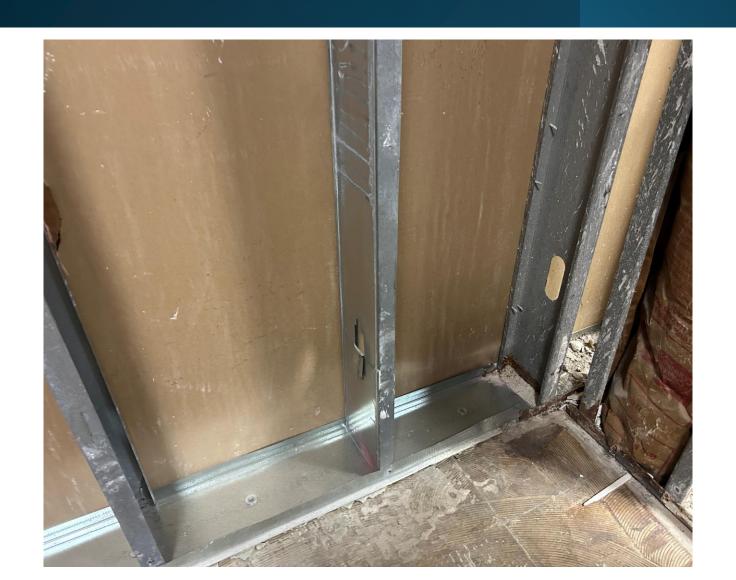

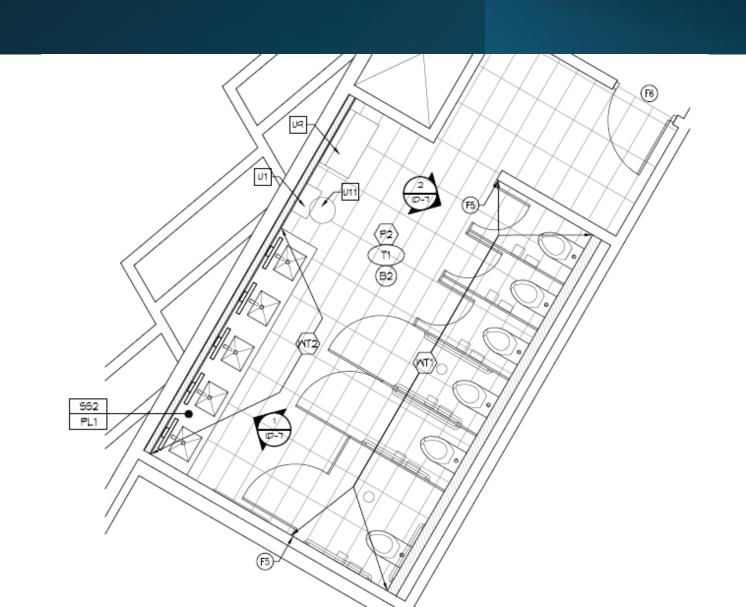

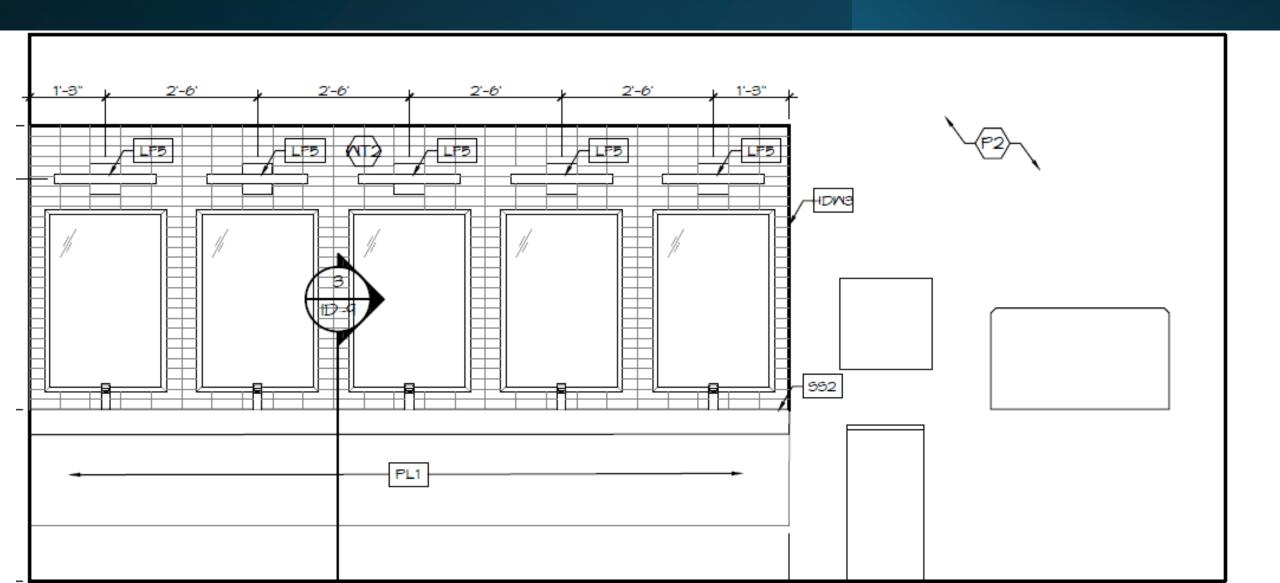




# Women's Restroom Layout
