As technology advances, we need your partnership in ensuring the safety and well-being of your child. Technology is a valuable tool if used properly and responsibly. A PHCA domain email account is issued to all Preschool - 2nd Grade students for educational purposes. Students are instructed in technology and have access to email and the Internet at school only with teacher-directed activity and selected websites. Instruction for responsible use of technology and the Internet should start at a young age, both at home and at school. Our goal is to help your child be responsible and develop the skills needed as they advance into the upper grades and become self-directed and independent with Internet use.

By signing below, I/We acknowledge that I/we have read and understand that:

- I/We must read the Student Internet Acceptable Use Policy (AUP); revised as of 6/2026 on the PHCA Website.
- My child will be using the Internet according to the AUP, accessing teacher-directed websites, and will be issued a PHCA domain email account to use for necessary educational purposes. I/We will be given, can change, ***must keep record of and remember my/our student's email/password.***
- PHCA's domain is school-managed. As such, PHCA may access PHCA domain email or change password as needed. As a school-managed domain, "Forgot Email Password" must be manually reset by the system administrator.
Parents/Guardians will be assessed a \$25.00 reset fee if password is needed to be reset more than two times.
- I/We hereby release PHCA, its personnel, and any institutions with which it is affiliated, from any and all claims and damages of any nature arising from my/our child's use of, or inability to use, the Internet. This includes but is not limited to claims that may arise for any unauthorized purchases.
- My/our child will receive age-appropriate instruction on guidelines and rules for Internet use at PHCA.
- I/we need to take the time to specifically reiterate to my/our child the *School Use of Electronic Devices for Educational Purposes*, *Personal Safety* and any other sections I/we may deem necessary from the Student Internet AUP.
- I/We will also discuss with my/our child the rules set forth in the Student Internet AUP and any additional personal rules I/we feel necessary that are above and beyond the rules set forth in the Student Internet AUP.
- I/We will emphasize to my/our child the importance of following the rules for their personal safety.
- In the event of an emergency or special circumstance that requires DISTANCE LEARNING, I/we agree to follow and direct/assist my/our child in following the Distance Learning Plan.
