FIRST CONGREGATIONAL CHURCH OF GUILFORD, INC Annual Meeting Minutes February 4, 2024

The Annual Meeting of the First Congregational Church of Guilford, Inc., was called to order by Jen Willcox, Lay Moderator. Ginger led us in prayer. She asked us all to call out one thing for which we are joyful this day and then led us into a prayer of gratitude. Jen read the Call to the Meeting:

CALL TO THE ANNUAL MEETING

To the members of the First Congregational Church of Guilford, Inc.: The Annual Meeting of the First Congregational Church of Guilford, Inc., will be held on Sunday, February 4, 2024 at 11am in the sanctuary, directly following the 10am worship service to:

- 1. Receive and act upon the reports and recommendations of the Ministers;
- 2. Receive and act upon the reports and recommendations of the Boards, Committees and Organizations of the Church;
- 3. Receive the report of the Nominating Committee and act upon their recommendations for Officers and Members of Boards and Committees of the Church;
- 4. Act upon the proposed 2024 Ministry Budget as submitted by Church Council; and
- 5. Discussion of the Visioning Process as it will unfold in the rest of 2024

It was noted that the plan for today will involve looking at the items in the call in a different order. First up: Receive and act upon the reports and recommendations of the Boards, Committees and Organizations of the Church. Members were directed to the Book of Reports for this information. There were no questions. A motion to approve was made and seconded. Vote unanimously approved.

Next: Receive and act upon the proposed 2024 Ministry Budget as submitted by Church Council. Stephen Dudley was invited to speak to this topic. A handout was given to those in attendance that included new information that came in after the Book of Reports was completed. This handout is the budget that will be voted upon today. Some key points: increased compensation for the new leader of Pilgrim Fellowship which will be paid for by their funds; there is a 1% increase for the staff and Sandy Wiens' retirement is reflected in the staff line item; we reduced proportional giving by \$2000; and a few more pledges have come in. This leaves us with a deficit of approximately \$33,000.

Budget facts: currently we have 178 pledges compared to 194 last year; 5 of these 178 pledges account for 24.5% of our budget; The carry-over is down by about \$10,000 from last year; Trustees income is down due to their 2 year averaging

We are blessed to have an endowment that helps defray costs/provide funds annually but it is clear that we can no longer grow our budget without financial resources and, based on our Stewardship campaign to date, it is clear that we are at a critical financial juncture. While Stephen moves that we adopt this budget, it must be with the following conditions:

- The ENTIRE congregation must work to eliminate the gap
- Fundraising must be undertaken...this would fall under special events in the income column and has been zero for the last couple of years. This can no longer be the case.
- Those who are able are asked to increase their estimated giving or give above it when they can
- Each board and committee must work to reduce expenditures.
- We may need to determine what missions/services we wish to continue(more resources would be needed) or reduce them
- Staff hours may need to be reduced.
- The Board of Finance must plan for the future with realistic expectations.

Questions: Nancy Mann: where is the money from the endowment reflected in the budget? The trustee distribution as well as the ministry contribution.

- Marcia Myhre: remember that we had a very successful auction some years ago-might that be a consideration?. We have had auctions, golf tournaments, house tours, dinners. The problem with that is that we need people to lead them and participate.
- Anne Godsey is willing to do fundraisers but she needs people to volunteer.
- Mark Gothberg: media platform services expense? Budget for this year was \$4000 and we spent over \$6000. For this year the budget is \$6000. Why was there a 50% increase over budget? Annemarie Alexa (Bookkeeper): this includes FellowshipOneGo subscription, the membership and accounting software and new this year we added in mailchimp which is the software to send out the emails. We pay hosts for the church website.

-He also asked about grounds upkeep: budget was \$3200 and we spent almost \$9000. This was because last year Mark was working full-time and this work was part of his salary. This year that has been broken up and we had to out-service some of those expenses.

- The cost of flowers....we spend over \$1000. Can members contribute flowers each week in honor of someone? Barbara Nickel: this is still available but fewer people do it since Covid. She has been doing the flowers for a fee of \$35 to cover expenses. To continue this we may need a point person to help with this. Many of the flowers are provided by Mary Jane Potter from the church garden and Barbara puts them together.
- Steven Hegedus: he agrees about fundraising. We need to think hard and strategically. He is concerned with the decline in pledges which has been steady since covid. How do we help here to support our membership, etc.? a follow up question: do people have to renew their pledge every year? Yes, we cannot assume that everyone's financial health is the same from year to year.

Motion and second to approve: vote - all approve.

Receive the report of the Nominating Committee and act upon their recommendations for Officers and Members of Boards and Committees of the church. The committee, Gail Tomsich, Peter Rebuzzini, Sandy Nicholas and Carl Frano are tasked to fill 181 positions. Gail highlighted some individuals who are going off their boards/committees and some who always go above and beyond. One correction for the Book of Reports: the chairperson for PAJ is Gini King. Peter reviewed those individuals who have joined/are joining committees. Motion made to approve the individuals listed to join committees. Seconded. Discussion: Marti Carlson-explained that when Mark Twombly, who was highly skilled and worked full-time, retired, his position was filled with a part-time janitor and then we had to contract out for grounds keeping. Vote to approve: all approve.

Receive and act upon the reports and recommendations of the Ministers. Ginger and Reilly: we have read the reports so what questions do we have for them?

- Gini King: we are glad they are here
- Nancy Mann: is there a special project or something that is important to them? Reilly: people seem hungry for fellowship this is something Reilly is interested in helping to develop these opportunities. Ginger: pastoral care-visiting homebound members, to hear and honor their stories. She wants to foster people to come and do that.
- Stephen Hegedus: thanks for both of them. Ginger for the mentorship she provided last year and Reilly for their awesomeness. Yesterday's Tiny Prayer workshop is exactly what we should be doing more of. Motion to accept reports of the ministers was made by Stephen and seconded. All were in favor.

Discussion of the Visioning Process as it will unfold in the rest of 2024. Ginger reported that next Sunday she and the deacons have a retreat during which they will have a zoom meeting with Paul Nickerson of Nickerson Coaching. Ginger has worked with him previously. He helps churches to identify their demographics and who are the people who may need us as much as we need them. How can we become a wider and deeper community where we can engage one another? We will be encouraged to ask each other questions, to pray together, to reflect on who we are and where we imagine that we are going. He will preach here in April and then will be available to answer questions after.

This completes the formal agenda for the meeting. Motion to adjourn made by Stephen, seconded by Bob Howard.

LEAD MINISTER'S REPORT Moments from 2024 -Submitted by The Rev. Dr. Ginger Brasher-Cunningham

We have entrusted Mary Mack, Virginia Bodin, Raymond Dudley, Tracy Warfield, Richard Walsh, and Ellie Leffingwell unto God's care. We pray for family and friends who begin a new year without their loved ones.

I am grateful for our divinity students, retired clergy, clergy, staff, and lay ministers who serve at and beyond First Church. They continue to help lead in worship, teach classes, and support our ministries. Our congregation continued as a teaching parish. What a joy to empower students and learn from and with them. Intern Freddie Swindall-Endres has enriched ministry life at First Church through their pastoral care heart and insights from their theological journey from one denomination to another.

Life and culture continue to change. Twelve years ago, our church began adjusting to a variety of new clergy and a changing world. We still have scars and growing pangs. Changing staff and pandemic years-aftermath have been unsettling. Now shifting staff is a common part of church culture and ministry. An average pastorate is five years.

Through the past nine years great transition has occurred. Our church has joined with four bridge ministers and three other full-time clergy in ministry. Our prison minister retired, and we no longer have the position. Three Pilgrim Fellowship Directors and two Directors of Children and Family Ministries have led our children and youth. We have had four office administrators and three financial administrators. In 2023 we shifted from a fulltime sexton to a part-time custodian. We still feel the sting of that change. At the end of 2024, our ministry assistant (our former office administrator for over two decades and our "glue") retired. The ripples of her departure are profound.

As we collectively hold all these shifts, turns, and feelings, we call ourselves to remember that church is not about any of us - specially - but about God's call for us to love others as Christ did. Jesus exemplified dreaming together about meeting needs of people and lovingly offered challenges as needed. As we embark on a visioning process, we hope to take our brokenness through the years, learn from it, and move forward as the spirit guides us.

I am ever grateful for the steadfastness, interactions with church community members, and for the gifts of our incredible staff. I am thankful to work with each one of our staff. They in conjunction with our church council, committees, and regular attenders ground us as a faith community ready to reshape and understand who we are now called to be in Christ.

- Implementing and leading worship services, confirmation, providing pastoral care through visitation, conversations, emails, calls, texts, and cards.
- Mentoring students, supervising, and assisting staff.
- Being available for boards, committees, and groups.
- Connecting with denominational programs.

- Keeping First Church's name in the community.
- Being attentive to interpersonal interactions and the unspoken. *And things that arise... Such Civil Rights History Trip to Charleston and daily surprises

DIRECTOR OF MUSIC MINISTRIES 2024 REPORT

This November, our choir sang the Requiem of Gabriel Fauré for the Annual Memorial Concert. When this requiem was first sung at a funeral service in the Church of the Madeleine in Paris, one of the musicians present noted: "Immediately after the ceremony was over, the vicar called Fauré into the sacristy and questioned him: 'What was that mass for the dead you've just conducted?' 'It was a Requiem of my own composition.' 'Monsieur Fauré, we don't need all these novelties; the Madeleine's repertoire is quite rich enough, just content yourself with that.'"

Imagine if that vicar's sentiment had prevailed. This Requiem would never have become a favorite of Barbara Eismeier; her daughter Christine Gill wouldn't have sung the solo "Pie Jesu"; her father John Eismeier wouldn't get tears in his eyes every time he hears that beautiful aria. I know that Barbara is present each time we sing that piece, because my heart remembers her.

Our Annual Memorial Concert is a memorial built of notes and harmonies and lyrics. It is "something that keeps remembrance alive" (Merriam-Webster) for a much-longer time then the nanosecond a sound wave enters the listeners' ears and is processed by brains' auditory cortices. The music gets intertwined with the remembrances listed in the program – George Baldwin, Tom Tomsich, Pamela Smith, Ronald Smith, Ben Lyster, Martha Rebuzzini, Floyd Corson, Magdalene and Helmut Haar, Charles Wilson, Anthony Sylvester, Stuart Lee Wilkie – beloved people who have shared life with members of our congregation. By retelling their stories, by sharing their names in our musical gathering, these people are present. Remember the sermon of Rev. Dr. Jeanette Zaragoza De León, who shared that in Latino cultures, for All Saints worship services, the names of the dead are read, and instead of ringing a bell as we do at First Church, all the congregation gathered respond aloud "¡Presente!". Present, in defiance of death. Present, in the faith of resurrection.

Why does our church hold a memorial concert, and memorial services? Theologians would say that a gathering in the face of death and grief provides comfort one to another, especially among those bound in a covenant like the Salem Covenant. Others would argue that funerals are a time to reaffirm faith in the face of loss; those in grief rely on the faith of their friends at times when their own faith may feel weak. I would argue that we are called in ministry by Jesus to memorialize. Remembering is, at its core, being mindful and considerate (the definition of the Latin word 'memor.') Remembering is also like that Norse mythology figure Mímir (another etymological root of our word 'memory'): the god who guards a well at a root of the tree of life, Yggdrasil, where all who drink from the well of memory gain wisdom and intelligence. In our monthly Christian memorial, we "remember on the night when Jesus was betrayed, he took bread." Is communion a re-enactment, like people who dress up and fight fake Civil War battles? No; in the sharing of our history and our stories, in the sharing of bread and cup, we all become 'presente' one with another, past and present. We are mindful and considerate of each other's joys and concerns. Memories are shared stories and experiences that become shared wisdom used in making new memories, which get added to and enhance our shared library of memories. Memories provide the wisdom and insight for visioning the way forward in First Church's years to come.

Many of the churches that are currently languishing are ones that see themselves as conservators instead of stewards. Conservators repair and preserve; the goal is to maintain something as it was created for as long as possible. Memories are treated as museum items to be conserved. Communion becomes a stale bread idol instead of a shared meal. Communion instead must be a story set simultaneously in time past and present, a song to be sung together by the living. During COVID shutdown in 2020, one of the most depressing moments for me was when I came to record a video for online worship, and upon opening the door of the vacant sanctuary I noticed a peculiar smell: the building had started to smell like a historic museum, without the weekly traffic of life in its walls. It has taken several years for us to recover our shared life together, resurrecting our shared living memory from the distanced life of epidemic.

This fall Amy Earls produced the musical 'Ordinary Days' at First Church. Our cast included

Julie Fitzpatrick, Amy Earls, Michael Lindsay, and Matt Landry-McWilliams. Amy didn't invest the time of so many people - rehearsing music and staging, painting backdrops, building stage sets (a big thanks to Matt Earls), installing lighting (thanks to our friends Brian and Peter and Larch and Jim), installing the stage (special thanks to Peter Rebuzzini and Peter Palumbo and a host of other muscles), etc. – just because it's something we used to do before COVID came. Our memory, our shared stories that grew out of past productions [Godspell, Joseph and the Amazing Technicolor Dreamcoat, Fiddler on the Roof, et all gave us all collective motivation to restart our church's stagearts program. Why? Example one: the Dreamcoat production brought Vicki Newman to our congregation as singer and choreographer. How less wonderful our lives would have been over these years without the Newman family being a part of our life together here! Example two: every time we stage a musical, we bring members of the community into our sanctuary who have never been inside our building before, and just maybe it won't be the last time. Example three: every time we produce a stage-arts event, we experience our sanctuary in a new way. Its strong bones (thanks to the Business Committee) has shown us that God's space, our holy worship space, has room to also be a shtetl in Ukraine (Fiddler) and a New York streetscape (Ordinary Days) and a weekly sharing of music (30 Minutes of Joy) and a meetinghouse to discuss gun control legislation (Ed Meyer) and a safe space for transgender youth and . . . we continue to draw the circle wide(r).

Our adult choir is not a conservator of past music. Yes, we do resurrect notes off the page, such as the motet by di Lasso we sang this spring. It was written in 1565 in Munich in Latin, a language now dead. Yet it came alive in worship in a UCC church 450 years later, because it was remembered through hard work in rehearsal on Thursday nights for months. Yet even as we remember the church's past, through composers no longer living (from Bach and Mendelssohn to Moses Hogan, Jane Marshall, Alice Parker, etc.) we celebrate the church's present with composers like John Rutter. Will Todd, Gwyneth Walker, Sarah Quartel, Mark Miller, Elaine Hagenberg, etc. We also hold the hard memory of recent racist upsurges in the United States. Our choir library repertoire since 2008 has 11.4% of the anthems composed by African Americans; looking at anthems prior to 2008, the library has 1.2%. Our memories of BLM give us wisdom on a path forward to make our worship reflect more of our wonderfully diverse creation and our wonderfully diverse God, and we actively seek out composers and music that give us amazing new visions of the Divine One. Singers (like Mary and Sam) who have newly joined our band of musical misfits bring us new wisdom and insight along with musical talent. And because we're in covenant together, they join as full partners in the firm, fully adopted members of the family. As we participate in visioning, it is important that we listen most attentively to our newest members who have found a spiritual home here: they hold the diverse memories that we desperately need to make our own.

Our Music Committee did the hard work of raising money to invest for the Sandin Organ Repair Fund and for the Myrtha Licht Fund, that we use to fund stage-art productions. We raise money through concerts and cabarets and a musical and our annual Mother's Day flower sale. Our committee is made up of dedicated stewards, caring for property that is not ours, that will be inherited by others. The Music Committee looks after the whole music program here, so that we might freely give it to the visions and dreams of those that come after us. The choir sings music because it gives us great joy, but also because we share our harmony with our fellow passengers as we journey together, shared as a beautiful gift, shared like a piece of bread around a table. Shared to be added to our covenanted memories together.

Fauré wrote: "As to my Requiem, perhaps I have also instinctively sought to escape from what is thought right and proper, after all the years of accompanying burial services on the organ! I know it all by heart. I wanted to write something different." The musicians and stewards of music at First Church have, like Fauré, endeavored to remember in 2024, yet to do something different, escaping from past walls of 'right' and 'proper'; and through each of those mini-resurrections found visions of new paths for 2025.

THE DIRECTOR OF CHILDREN AND FAMILY MINISTRIES AND THE CHRISTIAN EDUCATION COMMITTEE – 2024 REPORT

From January of 2023 through June of 2024, we continued our in-person, post COVID Sunday school program. More than seventy children participated in our weekly gatherings from nursery through to eighth grade. With twenty faithful volunteer teachers and student teachers we continued to study characters from the Hebrew Bible for our curriculum entitled, "Broken Vessels, Heroes of the Hebrew Bible." We looked at the stories of ordinary broken people whose lives were used to change the course of history leading to the birth of the Messiah. Each Sunday we try to tell each story three ways in order to strengthen each child's familiarity with the story and enhance the possibility that the story will create a faith connection to God.

We ended our curriculum year in June with Children's Sunday. The children led the morning worship service by telling the story of Abraham, Joseph, Rahab, Moses, Jonah and others. It was wonderful to be able to listen and participate as they did the call to worship, readings, and help serve communion.

Over the summer, the Children's ministry focused on Psalm 23. Children, church members and others helped me develop the 10:16 Moments as we creatively told the twenty-third Psalm together.

In September we held our "Welcome Back Party" for the children, their teachers, staff of First Church and new families. It was dually purposed, both to see each other again after the summer as well as to register children who wanted to attend Sunday school who had not already done so. Close to one hundred children and their families attended.

This year, our Sunday school program follows the same module we followed before. Our children's chapel time reflects the integrity of the adult service. It includes worship music, a Bible story, an offering, the Lord's prayer, and a corporate blessing. This year we are studying Jesus and those he met in his journey who were marginalized. So far we have studied the stories of Jesus and John the Baptist, the lepers, Blind Bartimaeus, the Magi. There are twenty teachers that rotate each Sunday and help make this all happen. We also have an incredibly supportive Christian Education committee that comes alongside to support faith formation for the children.

Our service projects this Fall included making cards and hand pies and delivering them to those in our church and community who are homebound or in need of cheer. The children assisted the prison ministry by bringing new toothbrushes for the backpack ministry and putting together compassion packs to give out to those in need in our community.

Our Christmas pageant took place on Sunday, December 15. Many thanks to Julie Fitzpatrick and Bill Speed for their assistance and support to the children this year. Sixty children participated in this service and many parents, grandparents, and others helped shepherds, the angels, the kings and prophets arrive at Bethlehem with Mary, Joseph and Baby Jesus. It was delightful as usual and was a meaningful addition to the Christmas season.

ENVIRONMENTAL MINISTRY TEAM 2024 REPORT

The mission of the Environmental Ministry Team is to inspire responsible stewardship of God's Creation by promoting witness, advocacy, and action within our congregation and in the wider community.

EMT's 2024 was "Living in God's Garden," and our goals were 1) to increase our garden output to send to CT Foodshare, The Branford Community Dining Hall and to those with food insecurity in our community, and 2) to enlarge our fellowship of Kinship Garden workers. Both goals were achieved. The garden produced/donated over 500 pounds, a 25% increase from last summer. To keep our environmental focus visible, ECO Echo articles were part of each *InSpire* newsletter, Creation care tips were listed in Sunday worship bulletins, and the EMT section of the church website was updated. An EMT table was outside of church with information about the importance of voting, and the church bells were rung 11 times at 11am on the 11th day of the three months leading up to the Presidential election to signal the "11th Hour of Climate Change." The EMT hosted Coffee Hour after worship in June, and had a table with environmental advocacy information and plant giveaways at the first Earth Day on the Green event in April. Sue Jones received our annual EMT Certificate of Appreciation. Several members attended at the annual IREJN Earthkeepers' Dinner in May. SNEUCC Conference Minister Rev. Dr. Darrell Goodwin and his spouse Ken, Ed and Patty Ann Meyer, IREJN supporters, were honored quests at our table. Members attended the SNEUCC Conference Justice Summit at Wesleyan in September. The EMT invited Lori Brown, Executive Director of the CT League of Conservation Voters, to speak at a Sunday Forum after worship in October.

The solar panels on the Moore building continue to produce excess energy, and some is being used for the new heat pumps in Fellowship Hall which provide heat or air conditioning as needed. The system produced another 28 megawatts during this past year. In the last four years, our carbon-neutral energy production is the equivalent of having planted 2328 trees and the system saves the church about \$3000/year in electricity costs..

The EMT is represented by Nancy Leckerling at the Board of Community & Global Justice meetings. EMT supports, through the CGJ, IREJN (CT IPL), and Outdoor Perspectives, a CT organization that offers counseling to youth through outdoor adventures. Nancy and Jon Leckerling continue to serve on the SNEUCC Conference Environmental Ministry Team, and Nancy coaches other UCC CT congregations in how to become "Green churches" through the SNEUCC Conference and IREJN.

New members are most welcome to be part of the EMT and we thank our members, past and present, who share their tireless passion about love of Creation and environmental justice--Mary Stevens, Lisa and Tom Finnegan, Susan Arnold, Sue Jones, Jon Leckerling, Bea Briggs, Nancy Mann, Mary Jane Potter, Ellen Durnin, Delores Connelly, Eugenia Barton, Sally Koslik, Rev. PARISH CARE TEAM 2024 REPORT

The Parish Care Team's (PCT) mission is to reach out to church members in need of support and comfort. The PCT, with information from our ministers, responds to the short & long-term needs of our congregation, to let them know they are cared for by their church family. Ongoing activities include sending notes of sympathy or support, giving rides to appointments, and arranging for meals for those who need short term help. As time allows PCT members visit and/or call individuals with ongoing difficulties once a month or more often.

At the 10am service each week the PCT person of the month cleans & gives out assisted hearing devices to congregants, and records the Joys & Concerns for prayers and emails these to the ministers and the PCT. That person is also responsible for placing a rose on the altar for births or adoption. At Easter and Christmas, the PCT wrote notes to members who are homebound, ill, injured, lonely or grieving.

PCT & others knit prayer shawls year-round. We thank all who knit for their time and talent. The shawls are blessed at our meetings and given to those who need comfort due to loss of friends or family members, surgery or illness. At least 30 were given out in 2024. The prayer shawl ministry began in 2004, so our church has offered this meaningful outreach to the church community and beyond for 20 years.

STEWARDSHIP COMMITTEE 2024 REPORT

The theme for the Annual Stewardship campaign was based on Paul's message in Romans 12 that we "love from the center of who we are; don't fake it." Through various outreach activities First Church family and friends were encouraged to display their love through action as Christ did.

- The campaign began in September 2024 when postcards were sent to First Church family and friends showing the percentages of the annual budget spent on Ministry, Christian Education, and Outreach and reminding recipients that their financial support of First Church is important.
- At the end of September, personalized letters were sent encouraging all to submit an Estimate of Giving for 2025 so that the 2025 budget could be built on realistic funding expectations.
- During October, congregants presented personal testimony at each Church service describing why they supported First Church financially.
- During October, November, and December, reminders were placed in the *InSpire* newsletter and in the weekly worship bulletins.
- In December, committee members sent emails and notes as reminders to those who had not yet submitted their Estimates of Giving.
- Committee members sent Thank You notes to those who pledged.

Thanks to the generosity of our parishioners, as of December 31, 2024, the Estimates of Giving total \$555,030 from 148 family units. This meets 96.4% of the \$576,000 goal. Our sincere thanks to all who submitted an Estimate of Giving!

- Funds transitioned to United Church Funds (UCF) in April 2024, remaining aligned with our Socially Responsible Investment Guidelines.
- Sage Organ Fund is now separately managed within the UCF platform.

Growth & Contributions:

- Net Endowment value increased by \$235,323.87 (7.6% gain) after distributions.
- David Knapp's bequest of \$1,118,266 established the Knapp Endowment Fund, supporting the Annual Ministries Budget starting in 2026. David Knapp, a dedicated church member since 1989, died in 2023 and his estate transferred the stock donation in August 2024.
- Chuck & Dianne Ramsey established a new \$30,000 fund effective for 2025.

Distribution & Impact:

- Average endowment value: \$3,189,107.87
- Planned 2025 Distributions:
 - Current Expenses: \$91,534.59 (~11% of operating budget)
 - Major Maintenance Fund: \$46,492.94

Treasurer's Report for 2024

Statement of Financial Position

The Statement of Financial Position (aka the Balance Sheet) shows the overall financial picture for First Church, excluding the Trustees' holdings and property equities. The 2024 report, showing both the Beginning of Year and the End of the Year (YTD, Year to Date), is attached.

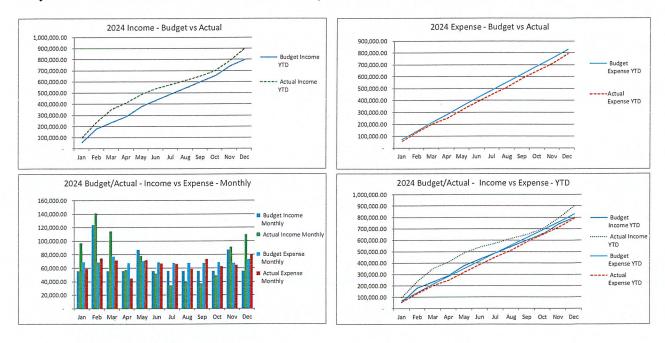
At the end of 2024 First Church's assets totaled \$455,272.50 up from 2023's total of \$412,616.13. In January 2024 the Webster Bank money market account was closed and the entire balance, \$45,929.65, was transferred to our high-yield savings account at Guilford Savings Bank (GSB). In May we moved an additional \$60,000 from the Webster Bank into the CD held at GSB. When this 6-month CDs matured in May and again in November, we reinvested the money in a new CDs with the same term limits, but at the going interest rate. At the end of 2024, there was \$180,142.75 in the Webster Bank checking account, \$100,585.16 in our high-yield savings account at GSB and \$113,951.90 in our current 6-month CD at GSB. During 2024, the Short-Term Investment Account First Church established in 2021 and is monitored by the Trustees saw an increase from dividends and market price, so we ended the year at \$57,592.25, which is up 15.2% from our initial investment of \$50,000. The church's other assets include the rental deposit on Spencer House, which was at \$3,000.44 at the end of the year. The sale of grocery cards, a Non-Cash Asset, ended in June and has a zero balance at the end of the year.

First Church's Liabilities include a clearing account for the credit card with Citizens Bank used for church expenses; health benefits and annuity for eligible employees along with payroll taxes withheld from staff prior to being billed for these expenses by the Pension Board; donations made in 2024 for 2025 pledges to the Ministries Fund; the Spencer House Rental deposit; along with money held in the Trustee Endowment Transfer account for money that will be transferred from Webster Bank checking account to the Trustees' holdings. The Total Liabilities for the year were \$24,384.04.

The Fund Balances (the church's Net Assets) represent the funds in which the church has money to use for its many ministries. The Ministries Fund is reviewed monthly by Church Council and is used to budget and monitor the finances for the church's operations. In 2024 the Ministries Fund income was \$898,796.93 while the Ministries Fund expenses were \$794,506.09 resulting in a YTD difference of \$104,290.84. Income came from parishioners who pledged, contributions to Designated Funds (from the Trustee Endowment funds) and miscellaneous income (which also included some donations made in 2024 for 2025 pledges). Expenses covered costs for administration, buildings & grounds, Christian education, clergy, music, Pilgrim Fellowship and outreach. The table below shows the monthly income and expense subtotals and the totals for the Ministries Fund. The resulting YTD Difference for the year (minus the money donated in 2024 for 2025 pledges) can be applied to next year's budget with a recommendation from the Board of Finance and approval by Church Council.

The graphs below show how we did financially compared to the approved Budget and includes all accounts included in the Ministries Fund. The graphs include the 2024 Income – Budget vs Actual, the 2024 Expense – Budget vs Actual, 2024 Budget/Actual - Income vs Expense – Monthly and the 2024 Budget/Actual - Income vs Expense - YTD. In 2024, we were above our total income budget for the year by 13%. Also in 2024, we were under our total expense budget by 6.9%. In fact, we were under budget in almost all Expense Categories while still maintaining the high quality of our many ministries at First Church. Great Job everyone!



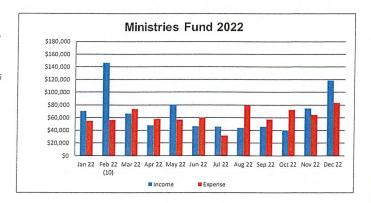

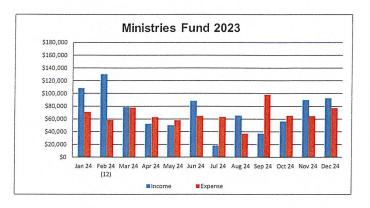

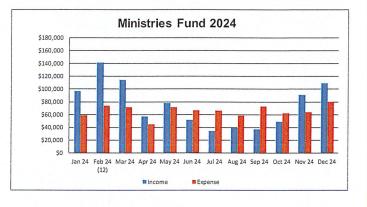

Budgeted Financial Statement

The Budgeted Financial Statement shows the actual activity within each Income and Expense account the church uses to track its finances, the budgeted annual amount for each account, and the differences between Actual and Budgeted amounts by account. The 2024 report is attached.

The Ministries Fund Income accounts range from 400000 to 409999 and the Ministries Fund Expense accounts range from 500000 to 509999. The Ministries Fund Income accounts are subdivided to match the Income subtotals on the Statement of Financial Position. Donations from parishioners who pledged are included accounts 400000 to 400199; contributions to Designated Funds are included in accounts 400200 to 400999; and miscellaneous income are included in accounts 401000 to 409999. Likewise, the Ministries Fund Expense accounts are subdivided to match the Expense subtotals on the Statement of Financial Position. Costs for administration are included in accounts 501000 to 501999, for buildings & grounds in accounts 502000 to 502999, for Christian education in accounts 503000 to 503999, for clergy in accounts 504000 to 504999, for music in accounts 505000 to 505999, for Pilgrim Fellowship in accounts 506000 to 506999, and for outreach in accounts 507000 to 508999.

The Income Accounts that range from 410000 to 499999 and the Expense Accounts that range from 510000 to 599999 are not budgeted by Church Council, but they do role up to the other Balance Funds that are monitored by individual committees and are listed in the Statement of Financial Position.
