Sports Registration Multi Child Discounts

- Policy:** A scaled registration discount will be applied to the total seasonal registration fees for all active parishioners of St. Malachy Catholic Church with multiple registered children.
- Purpose:** To provide financial assistance to multiple child households. We empathize with the financial hardship having larger households can place on families. In order to address this hardship, the discount hopefully enables all families, regardless of size, to participate in faith driven and competitive athletics.
- Scope:** All active St. Malachy parishioners. This includes both parents and grandparents of participating children. To be considered for a discount, the family must have registered at the church six months prior to a final registration date. Other circumstances might be considered, example being, family just moved into the community. Please discuss with the Athletic Director for guidance.

Procedure:

- 1.0 Application (via <http://stmalachy.org/church/serving-sharing/athletics-cyo/>)
- 2.0 Discount Scale
- 2.1 The most costly sport will be paid for at 100% of the registration fee.
 - 2.2 The next sport registration will be discounted 25%. This will also be the second most costly sport.
 - 2.3 The third sport registration will be discounted 50%. This will be the third most costly sport.
 - 2.4 The fourth sport registration will be discounted 75%. This will be the fourth most costly sport.
 - 2.5 If there are more than four registrations during a season. A 100% discount will be applied to all others.
- 3.0 The athletic ministry reserves the right to question, or further inquire, about a family's status at St. Malachy. Again, we hope by providing financial assistance it will allow more participation and relieve some financial burden.

4.0 For purpose of this policy, each St. Malachy Athletics' fiscal year (e.g. 2024-25, 2025-26, etc.) will consist of five seasons as follows. The discount will apply to households with two or more registrations within a given season.

- 4.1 Fall I – cheerleading, cross country, fall kickball, football
- 4.2 Fall II - girls volleyball, high school boys and girls volleyball, chess
- 4.3 Winter I – boys basketball, high school boys and girls basketball
- 4.4 Winter II – girls basketball, wrestling
- 4.5 Spring – boys volleyball, baseball, golf, soccer, softball and spring kickball

Examples:

- The Smith family has three children, Peter, Paul, and Mary. Peter is registering for Fall football (\$125), Paul for Fall cross country (\$65), and Mary for Fall Cheerleading (\$50).

If the family applied for the multi child discounts, the total charge will be \$198.75. Historically the total charges would have been \$240. It is calculated as follows:

Football	100%	\$125.00
Cross Country	75% x \$65 =	\$48.75
Cheerleading	50% x \$50 =	<u>\$25.00</u>
Total		<u>\$198.75</u>

- The Large family has five children, Noah, Jonah, Micah, Isaac, and Bert. All the boys are registering for Fall football (\$125/child).

If the family applied for the multi child discounts, the total charge will be \$312.50. Historically the total charges would have been \$625. It is calculated as follows:

Football (1 st Child)	100%	\$125.00
Football (2 nd Child)	75% x \$125 =	\$93.75
Football (3 rd Child)	50% x \$125 =	\$62.50
Football (4 th Child)	25% x \$125 =	\$31.25
Football (5 th Child)	Free	<u>\$0.00</u>
Total		<u>\$312.50</u>
