- c. The Foundation is planning an educational seminar on generational giving later this year. The seminar will be delivered by representative from Johnson Investment Council.

a. The revised staff handbook is currently being reviewed by legal council. The committee will meet next on September 16 to go over results from the review.

7. Old Business: Nominating Committee - Molly Hagkull

- a. Nominations are due to Nominating Committee on September 9 for both Governing Board and Deacons. She asked all Governing Board members to submit one nomination.
- b. Nominations for Nominating Committee will be discussed at the October meeting.

8. Senior Minister's Report - Glen Miles

- a. Glen reiterated what a great staff we have.
- b. He notices an increased sense of kindness and gratitude in the church.
- c. Our 2025 Giving Campaign, *Measuring What Matters: Journey to Generosity*, starts September 15. It will end on September 29, "Commitment Sunday."
- d. Year-to-date attendance is up 20% over last year. We're not quite at pre-Covid levels but getting close.

9. Finance Report - Liz Compton

- a. At the end of July we were \$238k below budget. Income of \$134k from logging at Akita will be booked in August, which will offset over half of that deficit.
- b. The forecast currently shows a loss for the year. The staff is doing a great job of managing expenses; the challenge is (and remains) a shortfall in contribution revenue.
- c. Cash flow continues to be a challenge.
