  - a. Eric Mulchaey, Partner, and Dan Jeffery, Sr Manager from ARM CPA attended to deliver the audit report for the 2023 financial statements.
  - b. Eric delivered the required communications: there were no difficulties, no misstatements, and no disagreements with management. This qualifies as a clean audit.
  - c. Molly Hagkull made a motion to accept the audit report.
  - d. Jim Hutchins seconded the motion.
  - e. An affirmative vote was unanimous.
- 6. Continuing Budget
  - a. Catherine Adams made a motion for a continuing budget through January 2025.
  - b. Rebecca Wolfe seconded the motion.
  - c. An affirmative vote was unanimous.
- 7. Financial Report Liz Compton
  - a. YTD through October we are \$100k below budget for the year. The forecast remains unchanged at \$224k below budget. The challenge remains the revenue shortfall, resulting in ongoing cash flow issues.
  - b. The 2025 Giving campaign remains encouraging. We have \$1.7MM in so far, up 13.75% over last year.
- 8. Senior Minister Report Glen Miles
  - a. Glen shared his reflections on leadership, particularly from Edwin Friedman's book <u>A Failure of Nerve</u>.
  - b. The FC South Assessment Team has formed 4 task forces:

Engineering Review, chaired by Pam Shisler Landscape and Engagement, chaired by Bill Mead Communication, chaired by Tom Stewart Interviews with FC South attended, chaired by April How

The full team has two meetings scheduled for December

- c. On Giving Tuesday, December 3, we will launch a year end campaign, Unwrapping Generosity. The goal of this campaign is to make up the budget deficit.
- 9. Nominating Committee Slate Molly Hagkull

- a. Molly presented the vetted list of candidates for Nominating Committee. Each GB member submitted their ranking of the candidates. Molly will tally the rankings and start calling from the top of the list to get to the final slate of 6 candidates.
- 10. PPRC Update
  - a. Molly explained the Sr. Minister Review form. She will send a Google doc to each GB member soon, so they may submit their review.
