7. Senior Minister Report - Glen Miles

- a. Highlights from Ben Horowitz's book *The Hard Thing About Hard Things*.
 - i. "Hard things are hard because there are no easy answers or recipes. They are hard because your emotions are at odds with your logic. They are hard because you don't know the answer and you cannot ask for help without showing weakness."
- b. Finish Strong campaign update: we have reduced our debt from \$2.1M to \$1.2M since May when we began the campaign. We have lowered our cash deficit from \$626K to \$429K. The Financial Leadership Team, chaired by Mark Hollinger, is continuing this work.
- c. Finish Strong Campaign Reenergized. This focus is asking the congregation to envision what it would be like to be debt-free, to dream with God about what is next for First Community's finances.
- d. Estimate of Giving campaign is being moved to January. The budgeting process will occur this fall, as it has in previous years, with some built-in assumptions about potential numbers. However, it will not be completed until the estimate of giving campaign is finished at the end of February.
- e. 2025-2026 ministry year overview. The new ministry year is off to a very strong start, with over 275 friends and members in attendance at the Kickoff Celebration, led by Kristy Glaser, director of member engagement.
