Tuition and Fees for 2024-2025

REGISTRATION FEE: K- 8: \$400 (\$650/family max)

The fee is due at the time returning student registration is submitted or sibling enrollment is approved. The registration fee is non-refundable and non-transferable.

Sibling registration must be submitted by February 29th, 2024 in order to receive the discount.

TUITION:

Grades K-5: \$9,965

Grades 6-8: \$10,155

Multi-Child Discount:

- 10% off 2nd student's total tuition
- 25% off 3rd student's total tuition

Tuition is due and payable for the school year beginning August 2024 through May 2025. All families are required to set up an account with FACTS Tuition Management.

Facts charges an annual one-time fee paid directly to them once your agreement is finalized.

- \$50 for 10-month plan
- \$15 for a semi-annual plan
- \$5 for paid in full

Payments are made by Electronic Funds Transfer (EFT) monthly in advance on either the 5th or 20th. At the time of enrollment, parents have the option of choosing either a 10-month plan (July 2024 – April 2025), two semi-annual payments due in July 2024 and January 2025, or pay in full option due by July 1, 2024. The school does not accept credit cards, cash, money orders, or cashier's checks for tuition unless otherwise stated. Tuition is calculated on the basis of the entire school year; therefore, NO deductions are made for school vacations, school holidays, or student absences during the school year.

NSF/LATE FEES: If any check, EFT, and/or online payment to WOLCS for any reason is returned for non-sufficient funds, you agree to pay FACTS a \$30.00 NSF fee and a \$25.00 late fee to WOLCS. If you incur more than two NSFs on tuition during the school year, you will incur a \$50 late payment fee for each occurrence (in addition to the NSF Fee), which must be paid in full. Parents will be notified by email or phone within 5 days of a failed EFT. Payment must be made in-house by personal check for all past-due tuition, NSF fees, and late fees. Should the tuition payment return NSF two times, the final method of payment will be credit card only and you will incur a 4.00% processing fee as well as all other applicable fees. All tuition and fees must be paid by the 28th of the month in order for the child to attend the 1st day of the following month. Failure to pay all past-due fees could result in a minimum 24-hour delay before a child can attend school.

WITHDRAWAL FROM SCHOOL: A 30-day written notice is required (see the school office for the form). You will be required to pay all fees during this time. NO refunds will be issued. Fees will NOT be prorated.

EXTENDED DAYCARE: Extended daycare (Kids Club) is available on school days before and after school hours for enrolled WOLCS students for an additional fee. Kids Club is available before school from (6:30-8:00am) and afterschool (3:15-5:30pm) unless otherwise stated for special events. Daycare is not available on school closure dates, holidays, or weekends.

Occasional use: \$15.00/ hour, billed by the ½ hour

AM Unlimited (6:30-8:00 am): **\$170/month**

PM Unlimited (3:15-5:30pm): **\$265/month**

Monthly Unlimited (both AM and PM UNLIMITED): \$380/month

MIDDLE SCHOOL PROGRAM FEE (6th-8th): The middle school-aged students, in sixth through eighth grade, are provided a time of preparation and transition from elementary school to the rigors of high school work. As individuals moving through a special stage of life, middle school-aged students have particular needs, which are met both through academic work and through the faithful ministries of caring teachers.

In order to continue to offer highly qualified teachers with specific specializations in the core content subjects areas, performing arts, foreign language, electives, various field trips that support the curriculum, higher education opportunities, and additional resources to meet the needs of quality education in California, a middle school program fee of \$350 will be added for the 2024-2025 school year. If not paid in full prior to the beginning of the school year, the fee will automatically be added to the cost of tuition and paid monthly only with the 10-month payment plan.

CAMP FEE (5th-8th): To be paid in full prior to the start of the school year or automatically added to the cost of tuition and paid over 10 months based on the total number of monthly payments of your tuition plan.

5th Grade: \$450 for science camp

6th Grade: \$600 for camp

7th Grade: \$600 for camp

8th Grade: \$650 for camp and graduation fees

MIDDLE SCHOOL BOOK FEE (6th-8th): A **\$350** student book fee is due prior to the start of the school year or automatically added to the cost of tuition and paid over 10 months based on the total number of monthly payments of your tuition plan.

FINANCIAL AGREEMENT:

We hereby acknowledge the acceptance of our student(s), for the privilege of enrolling as a student in Water of Life Christian School for the upcoming year.

- We accept responsibility for obeying the rules and regulations by which the school is operated and so support the Christian principles for which it stands. We agree to conduct ourselves and communicate in alignment with Biblical standards and the philosophy of the school.
- We accept responsibility for any loss or damage to school or church property that our student may cause.
- We understand that as parents/guardians, we may withdraw our student from Water of Life Christian School at any time without due cause; however, we understand that a 30day notice is required stating the last date of attendance and reason for withdrawal. Financial obligations to Water of Life Christian School will remain in effect until 30 days after the written notice is received.
- We understand that the tuition does not cover the full educational costs and as we are financially able, we will prayerfully consider supporting the school's fundraising events.
- We understand that our school account must be kept current and paid in full before the
 end of the school year. School account includes but is not limited to tuition, sports,
 extended daycare, late fees, etc.
- We understand that our account becoming delinquent for more than 10 days is a serious matter and will incur penalties. We understand that our account becoming 30 days delinquent may mean immediate removal of our student(s) from classes until the account is brought current.
- We understand that our students may not participate in student activities including, but not limited to, sports, science camps, and promotions/graduations if our account is not current. We also understand that no credit for our student's work can be earned unless all financial obligations are paid.
- We understand that grade cards and student records will be released when ALL accounts with Water of Life Christian School are current each trimester/semester of attendance.
- We agree to pay our tuition using one of the following options:
 - Kindergarten through 5th grade:
 - Full payment due on July 1, 2024 (3% discount)
 - **K-5**= \$9,666.05
 - 50% payment on July 1, 2024, and January 1, 2025 (no discount)
 - $\mathbf{K-5} = \$4,982.50 (x2)$
 - 10 equal payments beginning July 1, 2024, and ending April 1, 2025
 - K-5= \$996.50 (x10)
 - o 6th grade -8th grade:
 - Full payment due on July 1, 2024 (3% discount)
 - **6th-8th** = \$9,850.35
 - 50% payment on July 1, 2024, and January 1, 2025 (no discount)
 - **6th-8th** = \$5,077.50 (x2)
 - 10 equal payments beginning July 1, 2024, and ending April 1, 2025
 - 6th-8th = \$1,015.50 (x10)
