<u>Call to Order:</u> Pastor Beth Case called the meeting of the Session of Memorial Drive Presbyterian Church to order at 6:31 pm in the Chapel. She opened by reading **Psalm 90:1.** "Lord, through all the generations you have been our home" and leading us in prayer.

**Call for Quorum:** The Clerk, Kelly Handel, affirmed that a quorum was present.

Stephanie Espinoza, Elder for Evangelism-New Members, gave a brief introduction and welcomed our fifteen covenant partners from the most recent new member class. Stephanie introduced our **Motion**: to receive the abovenamed friends as Covenant Partners at MDPC. Those online and those in the room were invited to introduce themselves, telling Session why they were attracted to MDPC and one place they wish to serve. Beth thanked them for the introductions and asked the three questions of membership. Beth then asked for the **Motion on the floor**: to receive the above-named friends as Covenant Partners at MDPC, which was made and seconded. The motion was approved unanimously and with great joy. Stephanie prayed for our newest members and Beth dismissed them with the invitation to remain for the duration of the meeting or to be excused.

### **Emotionally Healthy Leadership** (Alf Halvorson)

At our staff and elder retreat, a month ago, our focus was on Pete Casarius..."so goes the leader, so goes the church" We had a big event Sat and Sunday-CITC-one of our Super Bowls- and after this Sunday, we have Ash Wednesday coming up and then 40 days of Lent...if we are not careful there are no margins...Prepare yourself now and get in a posture for 9 minutes of audio- to listen - listen without visual stimulation -to John Mark Comer -based on Richard Swenson's book <u>Margin</u> – about the necessity-the crucial aspect of having margin in our lives and a healthy balance- Richard A. - React to this. If overload applies to you, which type? Activity/Change/Choice/Commitment/Choice/Debt/Expectation/Information/Media/Noise/Fatigue....
- Agree or Disagree: do we live in an "achievement society?" and how is that similar or different than the culture in which you grew up?
- Where do you see depression (as John Mark Comer describes it) prevalent in your family, ministry, self?

Great dialogue followed amongst Session and Staff. How can we as a Session have an Upper Room and a Board Room? How do we have margin in our meetings? How can we be efficient but connect with each other and do meaningful work and listen to God? Roberta Hestenes, Eastern University said -if you don't deal with what people are coming in with from in the world, before the meeting, then they are not fully present...they bring in baggage and their load- the meetings can take longer, more distraction, etc.-

Can we pause for a minute and be fully present to God and to each other? Maybe tonight, for the next 45 minutes, can we be fully present to God and to this agenda- perhaps this is how we, tonight, deal with the margins. Alf closed us in prayer to wrap up this portion of our meeting.

- ECO National Gathering Recap- 1300 people at Highland Park Pres in Dallas every 30 minutes, 6 breakout sessions- great attendance from staff-Joe Stockdale only officer in attendance- in late January 2026, we will be in Atlanta, GA for the next ECO National Gathering- Joe encouraged us to plan to attend.

### **Treasurer's Report**: (Chris Arend)

We are always looking at our expenses and always looking at our contribution income. We are comparing numbers to last year, to the budget, and week to week with a monthly statement- we are a little behind from last year, however, we are underspending and net positive- so we are doing alright! We are to watch and look at this point- we are still early on. How are we spending and how are we doing with contributions? We are to look at some topics in the coming months that Session can learn from and understand. Tonight: What is the significance of our Operating Expense Budget if we at the end of the year go above or below? And what's our role? To be good stewards as Elders, Deacons, and MDPC Staff.

### **Church in the City God-Sightings and Immediate Impressions** (Rachel Poysky and Amy Delgado)

Rachel thanked all the Outreach staff and Amy Delgado. Here at the church, we made just under 27K sandwiches for Kids Meals, and many successful partner projects in the gym to include STAAR snack packs for six area elementary schools, easter eggs- Rachel asked for site reports from -Mission of Yahweh, Santa Maria, Food Bank, Spring Spirit, Magnificat House. She acknowledged the fellowship amongst our own members- growing our roots! The dream from the beginning with CITC was to be outside the church- where we are still trying to push out, we recognize how many we are meeting that are on the fringes of MDPC, feeling comfortable to come serve-either on campus or off.

### Baptism Reaffirmations with anointed oil

- MDPC will offer baptism REAFFIRMATIONS for those who were baptized either by sprinkle or immersion in the Presbyterian Church or another Christian congregation/denomination. This will be offered to the English-speaking,
- Fuente and BPC congregations at MDPC.
- The reaffirmation will allow individuals to publicly renew their baptismal covenant, acknowledge their faith, and allow the congregation to reaffirm their commitment to them in their discipleship journey.
- During the Baptism Reaffirmation, the person might introduce themselves, read a personal scripture, give a 1-4 sentence testimony, and be anointed with oil by a pastor. The moment might end with a congregational response/prayer. The Presbyterian Church (ECO) recognizes baptism as a one-time sacrament that is not repeated (Ephesians 4:5-6). Therefore, oil will be used as a sign of the Holy Spirit's presence and blessing. (Luke 3:21–22)
- The reaffirmations will only be scheduled on SPRINKLE baptism dates as it would connect them back to their baptism as an infant. Also, there is not enough time to add reaffirmations on baptism dates that include both sprinkle and immersions.
