# 2024 SCHOLARSHIP RENEWAL APPLICATION

## REQUIREMENTS

1. Applicant must be a member of Covenant United Church of Christ.
2. Applicant must have received a CUCC High School Scholarship.
3. Applicant must be a full-time student and **apply for renewal each consecutive year.**
4. Applicants with interruption of full-time status will not be eligible.
5. Applicants must be a full-time student in good academic standing with a minimum GPA of 2.0.

- Receipt showing you applied for your official final transcript for the current school year. Mail to the attention of the CUCC scholarship Ministry.

\*If you do not have your official final transcript at the time of your application submission, please submit a receipt showing that you have requested the final transcript. The status of your application will be incomplete until the official transcript is received.

- Proof of Fall Registration (minimum of 12 credit hours). Mail information to the attention of CUCC Scholarship Ministry no later than September 1, 2025.
- Submission:** Submit completed application and required documents to the Scholarship Ministry:
