# **Bethesda Lutheran Endowment Funds**

## **History**

The Bethesda Lutheran Church Endowment Fund Committee was established with bylaws passed at the annual meeting in January 2000. This committee invested your donations in stocks, bonds, money markets and cash reserves. Your gifts grew from nothing to nearly \$400,000 with no disbursements. To allow members of Bethesda to use Endow lowa tax credits, we contracted with the Story County Community Foundation in 2015. The first distributions from the endowment funds occurred in 2018.

Story County Community Foundation is an affiliate of the Community Foundation of Greater Des Moines which provides financial and administrative services. The Greater Des Moines Community Foundation currently manages 2300 charitable funds with over \$800 million in assets. The Story County Community Foundation currently manages 178 charitable funds with over \$28 million in assets.

The money in the endowment funds is divided between 75% actively managed with a long-term growth strategy and 25% growth mutual fund index. There is a 1% management fee for both funds. They have performed equally well.

## **Basics** General Endowment Fund

In June 2015, a stock account with \$396,784.52 was transferred to Story County Community Foundation. As of June 2022, an additional total of \$178,316.99 has been donated to both funds. Counting distributions and management fees from both funds, \$172,087.15 has been used as of June 2022. No distributions were budgeted for 2023.

## **Endow Iowa Fund**

Donors can take advantage of the Endow Iowa tax credit by working with the Story County Community Foundation which is a qualified community foundation.

#### Gifts that qualify include:

- Cash
- Real estate
- Stocks
- Bonds
- retirement assets

A tax credit of 25% of the gifted amount can be taken in calculating Iowa income taxes. Maximum annual tax credits are \$100,000 for individuals and \$200,000 for couples. Not all tax credits are granted by the state. The cumulative yearly total is limited to \$6 million and requires a separate application and approval.

#### Donors are advised to review their individual circumstances with their tax advisor.

The fund shall expend distributions to complement and supplement the ministry of Bethesda Lutheran Lutheran Church.

#### Our endowment funds have supplemented our evangelical ministry in the following ways:

- Remodeling the duplex for immigrants and refugees
- Payment of long-term debt
- Improved sanctuary lighting
- Electronic locks

### What more could Bethesda do with these extra funds?

Your gift will always be there to help those who come after. Changes in the bylaws are needed to simplify budgeting and to reflect how most endowment distributions are now handled.

### **Recommended Changes in Bethesda Bylaws Regarding our Endowment Funds**

C5.05.01 The name of the Endowment Fund will be the Bethesda Lutheran Church of Ames, Iowa shall have two Endowment Funds (herein referred to as "the fund"). One called the BETHESDA LUTHERAN CHURCH GENERAL ENDOWMENT FUND and the other, the BETHESDA LUTHERAN CHURCH ENDOW IOWA FUND.

4. Receipts and Distribution of Funds: the principal of the fund shall remain in place and only the distributionsgenerated by this investment will be disbursed each year. The congregation shall annually have access of up to five percent (5%) of the General Endowment Fund and up to five percent (5%) of the Endow Iowa Fund (per Iowa Iaw) based upon their values on December 31st of the previous year. The funds shall not be used for daily operations of the congregation but may be used for special projects and to pay down long-term church debt.

5. The congregation shall have access of up to one hundred (100%) of the General Endowment Fund based on a recommendation of the congregation council and approval of 2/3 (two-third) of voting members at an annual or special congregation meeting.
