Wedding Fees for Church Ceremony

- **Custodian Fees** \$150.00 for cleaning the church and an additional \$100.00 for cleaning Boatner Hall (prior to the wedding only).
- Sound Technician \$100.00 Note: Only Parkway Baptist's approved media personnel are permitted to operate the church's sound equipment.

• Media Personnel Note: Only Parkway Baptist's approved media personnel are permitted to operate the church's media equipment.

- \$100.00 if the couple provides a pre-prepared video.
- \$120.00 if our staff prepares the video.
 Note: The pastor must approve all pictures, music, and videos of the ceremony.
- Church Pianist \$100.00 (Couples may choose their musicians if preferred.)
- Pastoral Fee N/A

Parkway Baptist Wedding Application Policy

- 1. If you plan to serve alcohol (beer or wine) at the reception, Pastor Sampson or the Pastoral Staff of Parkway Baptist will be unable to officiate your wedding or permit the use of Parkway Baptist facilities for your ceremony.
- 2. Please schedule all auditorium pictures before departing for reception so that the custodian can promptly clean the church.
- 3. If you intend to use Boatner Hall, please ensure that birdseed or bubbles are used **only** in outdoor areas.
- 4. If you plan to incorporate media into the wedding, all photographs must be approved by Pastor Sampson or the Pastoral Staff. They reserve the right to request the removal of any photos that do not align with the values of Parkway Baptist.
- 5. Premarital counseling is mandatory as prescribed by Pastor Sampson or the Pastoral Staff. If conducted by Pastor Sampson, sessions will be held in his office. If conducted by other pastoral staff, the location will be determined accordingly. Both the bride and groom must attend all sessions. Failure to do so will result in the termination of the agreement to use Parkway Baptist facilities and all pastoral services for the wedding.
- 6. The bride and groom agree to be responsible for keeping their counseling appointments. Any cancellations must be made by 3:00 P.M. on the day before the appointment. However, understanding that circumstances may change, cancellations should be communicated as soon as possible. The Pastor will extend the same courtesy.
- 7. If issues arise during counseling that indicate a need to postpone the wedding, additional counseling will be recommended before proceeding. The wedding agreement may be suspended if a pattern of behavior suggests incompatibility or if unresolved issues could

hinder a healthy marriage. In such cases, the agreement will be canceled until the couple meets the necessary requirements to use Parkway Baptist facilities.

8. Both parties agree to make a sincere effort toward personal growth and actively engage in counseling during this critical stage of their lives.
