Over the past 18 years, CFMC has grown from a service area of 10 to 33 counties, from two to 234 sites by mid-2025 (184 of which are school-based health centers), a workforce of over 1,100 employees and spans five of Kentucky's six U.S. Congressional Districts. Both US Senators Rand Paul and Mitch McConnell, along with US Congressman Ed Whitfield, James Comer, Hal Rogers, Andy Barr, and Brett Guthrie have repeatedly visited our sites.

Yet our mission remains the same:

To increase access to affordable, high-quality primary and preventative health care to eliminate health disparities.
