WELLSFEST AND VENDOR AGREEMENT

REGISTRATION DEADLINE: Signed agreement and \$60 fee must be postmarked by September 1, 2025.

This agreement exists between WellsFest (c/o Administrative Council, 2019 Bailey Ave., Jackson, MS 39213) and Vendor for the last Saturday in September 2026 for the hours between 7 a.m. until 5 p.m. or any part of that day or those hours in accordance with standard festival hours of 9:30 a.m. until 4 p.m. This agreement also serves as documentation that the vendor understands and agrees to the stipulations found below:

I/We, the vendor/vendors, agree to:

- ✓ Pay WellsFest in advance the sum of sixty dollars (\$60.00) for the vending of wares during the day of the festival held at **MS Agriculture and Forestry Museum (MAFM)**. Vendor fees are not refundable unless the festival is canceled.
- ✓ Abstain from the sale or distribution, in any fashion, of any alcoholic or drug-related merchandise or paraphernalia, exploding merchandise, knives, whips, or any item that may render harm or injury.
- ✓ No food or drink items of any kind are permitted to be sold.
- ✓ Abide the alcohol-free/drug-free emphasis of the festival by not consuming/distributing same on the grounds.
- ✓ Set up and dismantle any and all items related to vendor space (tent, table, chair, wares, etc.).
- ✓ Move my/our vehicle/vehicles from the vendor area by 8:30 a.m. (NOTE: We will provide detailed set-up, entrance & exit information closer to the festival for your and other vendors convenience).
- ✓ Locate my/our vending space in the area assigned by the recognized leadership of WellsFest.
- ✓ Recognize that the allocation of 12'x12' spaces will be on a first-come first-served basis upon receipt of payment to WellsFest.
- ✓ Accept any liability directly related to merchandise offered by me/us at WellsFest.
- ✓ Refrain from playing music or musical instruments in the vendor section. No generators are allowed.
- ✓ Adhere to the stipulations of the agreement with the understanding that violations could result in being asked to leave the assigned site without a refund.
- ✓ Be responsible for any tax obligations on sales by the vendor.
- ✓ Comply with all MS Agriculture and Forestry Museum rules and vendor regulations as applicable.
