This Agreement is between WellsFest (c/o Administrative Council, 2019 Bailey Ave., Jackson, MS 39213) and the Food Truck Vendor identified below (“Vendor”) for Vendor’s participation at the WellsFest festival on Saturday, September 26, 2026, between the hours 7 a.m. and 5 p.m. and in accordance with standard festival hours of 9:30 a.m. until 4 p.m. This Agreement also serves as documentation that Vendor understands and agrees to the terms and conditions set forth below:

Vendor agrees to:

*Pay WellsFest in advance the sum of three hundred dollars (\$300.00) for permission to sell food from Vendor’s food truck during the day of the festival held at Jamie Fowler Boyll Park. Vendor fees are not refundable unless the festival is canceled. **Please make checks payable to WellsFest and mail to the address at top of this Agreement prior to August 31, 2026, along with your proposed menu and prices for the event. Shower Power receives all proceeds (100% net) from this event. WellsFest does not financially profit in any way. [Terms and Conditions are continued on the next page.]**

- * Abstain from the sale or distribution from the Vendor's food truck of any food or beverage item sold by WellFest itself. These items include all beverages, snow cones and cotton candy.
- * Provide all electrical power, water and other utilities required for the operation of the food truck.
- * Provide all supplies, equipment, and personnel necessary to operate the food truck, serve food and make sales to customers.
- * Set up, dismantle, and remove any and all items related to Vendor's use of the space (tent, table, chairs, empty containers, refuse, etc.).
- * Remove any vehicles other than the food truck from the food truck vendor area by 8:30 a.m. on the day of the festival.
- * Abide by the alcohol-free and drug-free emphasis of the festival by not consuming or distributing same on the festival grounds.
- * Locate Vendor's food truck in the area assigned by the recognized leadership of WellsFest.
- * Recognize that allocation of food truck spaces will be made within the sole discretion of the WellsFest leadership.
- * Accept any liability directly related to items sold by Vendor at WellsFest.
- * Refrain from playing music or musical instruments.
- * Adhere to this Agreement with the understanding that violations could result in Vendor being asked to leave the assigned site without a refund.
- * Submit a proposed menu with prices along with the completed and signed application.
- * Serve and sell only the items listed on the proposed menu or the substantial equivalent of those items.
- * Be responsible for any tax obligations on sales by the Vendor.
- * Comply with all applicable city, county and other ordinances and vendor regulations.
